Citing her family, she moved back to Las Vegas to practice law, first returning to the law firm where she got her start before moving to Marquis Aurbach in 2003. Throughout the rest of the interview, Tomich discusses values, what it has been like balancing a family with a full-time job, and what parts of Filipino culture she has retained.
