The Office of the President has also been responsible for maintaining meeting files and agendas of official duties, as well as maintaining local and regional public relations. ### **Scope and Contents Note**

The University of Nevada, Las Vegas (UNLV) Office of the President Records (approximately 1950-2007) detail the activities of administrative offices, colleges, departments, faculty, alumni, and students of the university. The records consists of correspondence with departments and organizations within the university as well as external organizations such as the Nevada System of Higher Education Board of Regents, the National Collegiate Athletic Association (NCAA), and the University of Nevada, Reno (UNR). Correspondence with governmental agencies, such as the

National Science Foundation, the United States Department of Justice, and the Federal Bureau of Investigation are also contained within the records. The records include financial documents, such as budget proposals and reports, salary proposals and reports, expense reports, donation and gift receipts, and financial ledgers. The records also include both program and physical expansion plans for the university as well as photographs, publications, newspaper clippings, statistical reports, and student surveys.
