Looking Down The Barrel

A Professor of Law at Duke University noted the 'the enlivened political awareness among college students is severely testing the ability of college administrators to maintain discipline without necessarily infringing upon students prerogatives. The resulting problem to treat students fairly without jeopardizing legitimate college interests has attracted renewed attention lately.' This professor went on to research some areas of state universities who reported on their own disciplinary procedures. The statistics reported that:

1. 43% of State Universities do not provide students with a reasonably clear and specific list which describes misconduct subject to discipline.
2. 53% do not provide students with a written statement specifying the nature of the particular misconduct charged, and only 17% provide such a statement at least 10 days before the determination of guilt or imposition of punishment.
3. 16% do not even provide for a hearing in cases where the student takes exception to the charge of misconduct or to the penalty proposed.
4. 47% allow students or administrators who appear as witnesses or who bring the charge to sit on the hearing board as if they were otherwise a member.
5. 30% do not allow the student charged accompaniment by an advisor of his choice during the hearing.
6. 26% do not permit the student charged to question informants or witnesses whose statements may be considered by the hearing board in determining guilt; and even including those colleges who normally allow cross-examination, 85% permit the hearing board to consider statements by witnesses not available for cross-examination.
7. 47% permit the hearing board to consider evidence which was 'improperly' acquired (such as removed by a University employee during a search of a student's room

in the absence of some emergency justifying such a procedure.) While certainly the situation is much brighter at UNLV, I think this is indicative that we here should take a look at disciplinary procedures for students generally in state schools. It has been said



that the maintainance of procedural due process for student offenders is substantially unnecessary. This proposition is supported by figures on student offenders obtained from Universities responding to the above survey. The figures indicate that less than 10% of the students denied the misconduct with which they were charged or take exception to the discipline imposed. Perhaps a related argument is that providing procedural due process for student offenders would be an economic extravagance. To require that students receive written notice of specific charges, that a hearing board be convened in every case, that counsel be admitted to the proceedings, that a transcript be made for purposes of judicial review, that witnesses be subpoenaed and that improperly seized evidence be excluded, would necessitate an unbearable increase in administrative personnel trained in legal skills, which together with the loss of time involved, would seriously injure all but the wealthiest institutions.

I would seriously disagree with the entire basis of the above observations. Students today are responsible, mature adults attending an institution with the purpose of education. Should it become necessary that they need some type of disciplinary action, this should be administered by their own peers and not at the administrative or

Dear Editor:

On Sunday, October 5, 1969, on the front page, under the heading 'UNLV Students Set War Rally': the Las Vegas Review Journal published an article stating that a 'massive protest rally, called the International Moratorium Day against the Vietnam War-is being planned by STUDENTS AT THE UNIVERSITY OF NEVADA, LAS VEGAS, for October 15.' This hit countless, responsible Nevadans of all ages like a bolt from the blue. Numerous parents, sacrificing for years to send a child to our University, were crushed at the thought that this local institution represented a radical, left wing political persuasion, of a degree that could launch a 'massive' Anti-American demonstration. continued on page 5

faculty level. The present system at the University of Nevada allows that in non-academic matters, the CSUN Judicial Board shall hear and adjudicate cases according to the procedures outlined in the CSUN Constitution. Their decision will come in the form of a recommendation which is forwarded to the Dean of Students for concurrence. If there is a disagreement, the case is then appealed to the Disciplinary Evaluation Committee composed equally of students and faculty members.

Of a more immediate concern is that in academic matters, students appear before the Discipline Committee, a subcommittee of the Faculty Senate for adjudication. It is my understanding at the present time that there are no clear lines of appeal in academic matters other than the informal channel to the President of the University. It would seem to me that we could combine many of the advantages if I allow the CSUN Judicial Board to adjudicate all matters of discipline, academic and non-academic. They would have the time to insure Constitutional due process and we would not have the slim majorities as noted above. The CSUN Judicial Board does have time to allow notification before a hearing. It DOES have the time to allow cross-examination of evidence and the right of a person to have counsel.

In the next Faculty Senate meeting Tuesday, on behalf of CSUN, I will ask the Senate to forward all cases of academic discipline for adjudication to the CSUN Judicial Board. I think it is a strong, positive movement in guaranteeing students' rights.

ANTI-WAR MORATORIUM TODAY

Today, starting at 10 a.m. there will be a rally before the Student Union protesting the War in Viet Nam.

This rally, sponsored by UNLV Student Mobilization Committee and CSUN will be UNLV's contribution to the moratorium throughout the nation today.

The rally will begin with speeches by Nevada State Assemblyman Norman Hilbrecht and Las Vegas attorney's Frank Schreck and Terrance Jones.

Following these speakers, Professor Dan Larson, Professor Gary Jones and Dr. Leonard Storm

will speak. Dr. Storm will also be conducting draft counseling during the day in front of the Union.

Patrick C. Clary, chairman of the International Affairs Committee of the Young Democratic Clubs of America, and John Cevette, president of CSUN, will speak at approximately 11:15 a.m.

After these speakers at 11:45, the rally will be adjourned to the Federal Building downtown where Former Governor Grant Sawyer will read the names of the Nevada Dead in Vietnam.

The vigil at the Federal Building will continue into the early

morning hours of Thursday.

Last night, students and members of the community held a vigil at the Federal Building at which the names of the United States war dead were read by members of the Las Vegas professional community.

The administration has announced that students missing classes to participate in the rally and vigil will not be penalized.

The National SMC hopes to get 1/2 to 1 million students and professional people and citizens to participate in this National Moratorium.

Nationally, some 51 congressmen and 19 U.S. Senators have endorsed the rally. The latest to do so was Kentuckian Thurbson Morton, a high ranking member of the Republican National Committee. Senator Charles Godell of New York has asked his fellow congressmen to join the students and take off on October 15.

SMC Co-Chairman Sid Goldstein commented on the reaction of the congressmen. 'This has become a

truly national effort citizens from all levels of American life will join our students in protesting his evil war.'

Open Letter

Nominations for Who's Who Among Students in American Universities and Colleges for the 1969-70 academic year are currently being accepted by the Office of Student Personnel Services, Room 120, Campus Student Union. Deadline for nominations is October 24, 1969.

Students are encouraged to submit their names to the Office of Student Personnel Services if they meet the following qualifications: Candidates must:

1. Be of regular senior standing in the University for this year. (Some outstanding juniors may qualify.) Those selected for Who's Who in the past cannot be considered.

2. Must have attained a cumulative GPA of at least 2.49.

3. Must have a record which denotes quality of leadership, integrity of character, and promise of effective, constructive leadership in post-college life.

Applications for WWAS should note, by year, offices and chairmanships held. Also listed should be memberships and all activities, organizations, sports, etc.

A committee appointed by the CSUN President, composed of students and faculty, will review all applications and recommend qualified students to the National Association.

An authority in the political and economic conditions of South Asia, Europe and East Africa, Thurston's overseas assignments included the political advisorship to the Supreme Commander of Allied Forces Europe in Paris; the directorship of the Office of Eastern European Affairs for the Department of State; and the Deputy Chief of Mission to the U.S. Embassy in Athens.

FOREIGN POLICY CONFAB

A conference to examine America's foreign policy during the past decade will be conducted, Saturday, October 18, at the University of Nevada, Las Vegas.

Dean Ralph J. Roske of the UNLV College of Social Sciences, said topics to be analyzed will include nuclear disarmament, the war in Vietnam, underdeveloped countries of the world, policies of foreign aid, problems of the draft and student dissent.

The conference is aimed primarily at updating the knowledge of teachers of political science and history concerning material too recent to appear in standard classroom textbooks.

Invitations have been extended to high school and elementary school teachers. However, the sessions are open to the public and should prove valuable to persons interested in American foreign affairs during the Kennedy, Johnson, and Nixon administrations, Roske said.

Sessions will be sponsored jointly by the history department at UNLV and the Service Center for Teachers of History, a division of the American Historical Association.

Cost of the conference is \$2, which includes a buffet luncheon. Full-time students will be admitted without charge. Registration is scheduled at 8:30 a.m. in the ballroom of the Campus Student Union.

Featured speakers for the event

are Dr. Armin Rappaport, professor of history and provost of the Third College at the University of California at San Diego; and Dr. Raymond Thurston, instructor in political science at UNLV and former ambassador to Haiti and Somali Republic.

Rappaport will discuss recent American foreign policy at a general meeting beginning at 9 a.m. Afterwards, the meeting will break into discussion groups, hopefully no larger than 10 to 15 persons, to investigate some of the meanings of Rappaport's speech.

Following the luncheon, Thurston will examine the U.S.'s role in assisting the underdeveloped countries during the past decade. His presentation will be followed by an extensive question and answer period.

A specialist in diplomatic and naval history, Rappaport is the author of three books: 'The British Press and Wilsonian Neutrality,' 'The Navy League of the United States,' and 'Henry L. Stimson and Japan, 1931-1933.'

In addition he has edited several books for college courses and has published essays in scholarly journals. He is serving as general editor of an eight-volume history of American foreign policy to which he will contribute the final volume on the Cold War.

For 18 years, Rappaport was professor of history at the University of California at Berkeley.

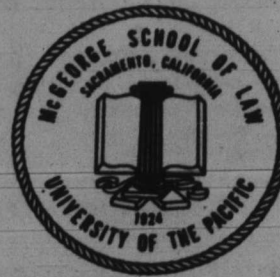

CANDIDACY - CAMPAIGNING

Here are the rules that must be followed in the pursuit of a political office. These rules are in accordance with both CSUN constitutional stipulations and University regulations.

CANDIDACY

- A. In order to actively campaign on campus, with posters, the Rebel Yell, or any publicly held, CSUN controlled Campaign Assembly, a candidate must file a CSUN Election Petition.
- B. In addition to petitions, each candidate running for an office in any CSUN body will be assessed a \$5.00 registration fee. This fee insures the Election Board that all actively campaigning candidates will stay within the satisfactory restrictions, and is due and payable with the presentation of the petition.
- C. Petitions and fees must be received no later than 5:00 p.m. on the posted deadline date.
- D. Individuals who do not file election petitions or pay required registration fees, may be considered as write-in candidates.
- E. Write-in candidates will not be permitted to actively campaign or be eligible for any CSUN campaign services.

CAMPAIGNING

- A. Official campaigning will begin two weeks before the scheduled election date.
- B. On the two days of voting by students, there will be no campaigning permitted within 100 feet of any poll.

C. Restrictions on posters and signs:

- 1. No posters or signs will be permitted inside of, or on the exterior surface of the library.

- D. All signs, posters, handbills (other than ads in the Rebel Yell) must be taken down no later than noon of the day following the close of elections.
- E. The entire registration fee will be refunded if all campaign material of a candidate is removed. Failure to comply with rule will result in forfeiture of the fee.

G. All funds collected by fault will be used by the Election Board (CSUN) to aid in covering election costs: printing of ballots, petitions, and publicity.

- Voters and Voting Procedures
 - a. It is the responsibility of all students desiring to vote to produce a valid CSUN ID card or library card as the only proof of CSUN membership.
 - B. Each voter will be cross checked with the registrar's IBM listing of name and University ID number.
 - C. Polls will be open from 8:00 a.m. to 4:30 p.m.

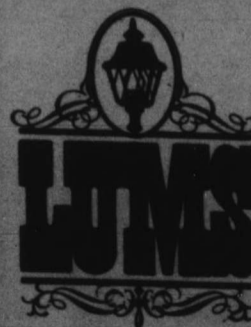

Names of two local lads who would head the festivities were given-one holding the No. 2 office in the student body. I have been reassuring these people and would like to repeat in print, by my analysis of the situation, that these first impressions must be faulty. First of all, if we're thinking locally and of our University, how massive could anything be? And massive by whose standards-the two boys who are 'heading it' or the reporter who wrote the article? If I might be permitted a little criticism of our journalist, I would remind him that this is the sort of thing that caused some real trouble in Chicago not long ago. A little sensationalism might spice up circulation of a paper but can cause serious division in the community-university relationship, especially in such a sensitive area as the Viet Nam War issue. If the facts are loosely handled 'someone over thirty' (and I don't mean Mao) I would like to give you the benefit of my twenty-five years experience with riots, subversion, guerilla activities, mob violence, student protests, palace intrigue and 'massive protest rallies'. If not comforting, you may find it educational.

Actually, our local kids aren't going to plan ANYTHING(as the article states). A few of them have in their immaturity, no doubt, been impressed by the 'National representatives' that visited them. The planning, however, was done long ago and NOT by the students. If you wanted to go back 50 years, most students of political history could give you the names and the philosophy of those who did plan it. More specifically and recently this October 15 protest, like the march on Washington, the Berkeley Riots, Assault on the Pentagon, Free(Obscene) Speech Demonstrations, Vietnam Day Demonstrations 65-67 and the Chicago Democratic Convention Disorders, were planned and coordinated by professional radicals, assisted and supported by members of the Communist Party USA and other garden variety subversives. The key word, to those sophisticated in the field is 'International'. No- vices should remember this word- It's the title of the Communist world-wide anthem and pronounced with emphasis on the last syllable. Even the most naive citizen knows our people at UNLV couldn't plan ANYTHING 'International' and have it happen by October 15. The orders come from the top down-not from the bottom up. 'International' is a communist trade-mark. When you see it used it is always attached to some program that is being used by their activists in a country they hope to overwhelm(like us).

I have before me official material several months old relative to the October 15 event. My information is that the Students for a Democratic Society (well-known communist sympathizers) after their September 26-28 protest, scheduled the 'war moratorium' to 'shut down schools and colleges for one or more days around Oct. 15.' Modus operandi of such fronts, the names of the 'movements' are changed as frequently as the House Internal Security Committee can list them for investigation. This one was called the 'Vietnam Moratorium Committee' Sound familiar?

What else the visitors to our

local people brought appears to be scheduled for the same date (November 14-15) as the 'Student Strike and March on Washington D.C.', isn't that a coincidence? Our local boys would, indeed, be having delusions of grandeur to believe for a minute that THEY were heading, coordinating, planning or doing anything but duping for these 'international' activities with which they may, innocently enough, have become involved. The clincher to the local announcement was the statement that they invited 'all patriotic organizations' to join them. Patriotic, yes-but to what Country? We can guess, when on a National scale this group waves the Viet Cong flags, sends blood and supplies to them and gives speeches praying for their victory over us and the South Vietnamese.

No one that I know, especially in the military, favors the Viet Nam War. The natural desire of Russia, Red China and the other Communist Countries for us to leave Viet Nam to be ravaged and taken over by them, is elementary. The excesses of our native 'protestors' are being purchased with the lives of loyal Americans now fighting there and possibly by the sacrifices of those who went before them in other conflicts. The article stated 'several U.S. Senators' were included in the membership of one of their groups. I wonder who they are. It seems inconceivable that any American at that level would participate in something that has, for several years, given the aid and comfort to our enemies that has enabled them to prolong this conflict so far after it should have ended.

I might add that the irony of the situation is that this is the only place on earth where a man can bask in the blessings of liberty, bought with blood of patriots, while conspiring with subversives and plying the profession (and a profitable one) of treason and spending a lifetime doing it. No wonder our kids are confused!

ALICE'S RESTAURANT A GOOD VOICE By Joe

'Alice's Restaurant' now showing at The Guild Theater is a lyrical satire about the circumstantial life of a number of progressive middle class kids. The same kids who would congregate at the Woodstock Music Festival by the hundreds of thousands.

In the starring role, Arlo Guthrie does everything but act—but being himself does more for the picture than a distinguished pro ever could mimic. The rest of the cast is in the same category—almost every one from the Blind Judge to Officer Obie play themselves with such realism that you can easily fit yourself in among them and believe it.

The story totally absorbs itself in the advent of a new era of human realization. It focuses on the attempt made by Alice and Ray Brock and their adopted kids to find a way out, to start a new life, and to create a system that would not fail. But, as many before them had found, it wasn't all that easy... It treats thoughtfully—and wittily—

the themes of youthful alienation and adult confusion.

'Alice's Restaurant' is surely a member of the new film revolution, but you must be careful not to assimilate it with films like 'Easy Rider' and 'Midnight Cowboy', two other members of the coup, for it is an entity within itself and cannot afford to be diluted by wandering into the depths of every social and ethnic problem that now confronts those who must sooner or later admit that they must sooner or later capitulate to the economic demands of a normal life.

In the final analysis, 'Alice's Restaurant' asks us to carefully answer the question of whether or not it is possible to resolve the break between the generation of the young idealist, searching for something that always seems to evade their best efforts, and the older, straight generation that has already given up the search—It's a good question to think about—for a long time.

SANTA CLARA BOMBS REBELS, 26-13

The University of Nevada, Las Vegas, dropped its second game of the season last Saturday night, losing 26-13 to the Santa Clara Broncos at Cashman Field.

Santa Clara scored first, following a Rebel punt. Bronco quarterback Don Pastorini hit end Bart Jenks for a 37-yard touchdown pass, capping an 80-yard drive. Bronco backs Mike Carey and Larry Holmes combined for 41 yards on six carries during the drive.

The Rebels, who played on an even par with Santa Clara in the first half, came right back with a six-play, 74-yard drive. Quarterback Don Kennedy hit Steve Buzick for 19 yards, moving the ball from the Bronco 46 to the 27. Mack Gilchrist rambled 22 yards a play later to score with 13:38 left in the half. Buzick's kick made the score 7-7.

Santa Clara replied to the Rebel TD with a 74-yard drive in 10 plays that culminated with Holmes scampering 23 yards, through three tackles, to put the Broncos on top for good, 14-7, with 9:37 in the half.

The scoring continued at a rapid clip. The Rebels received the kickoff on their own 30, and on the first play from scrimmage George Sapphire sprinted down the sidelines for a 55-yard gain, taking the ball to the Bronco 15. Gilchrist plunged for three and Kennedy picked up a first down, rolling out to the two yard line.

The Santa Clara defense dumped Kennedy for a one yard loss, but Gilchrist scored from the three. Buzick's kick was wide, the result of a bad snap, and SC was on top 14-13.

A Kennedy pass interception on the Bronco 45 lead to the final score of the half.

Pastorini threw to Jenks for 17 yards. After a holding penalty moved the ball back to the 42, Pastorini threw to Jenks for his second TD of the game with 3:22 left in the half. The Broncos took a 20-13 lead into the lockerroom, after the kick was wide.

Santa Clara began the second half with another long drive, Carey scoring from the 12 to cap a 75-yard drive. Pastorini's attempt for

a two-point conversion was foiled when Ray Deshane dropped him behind the line of scrimmage.

Pastorini was injured in the third quarter, when he was sacked on an attempted pass. From that point the game was rather boring, except for a short Rebel drive late in the fourth period.

Gilchrist racked up 108 yards rushing for the third game in a row, carrying 17 times for a 6.5 average. Santa Clara's Holmes carried for 176 yards and the same average as Gilchrist.

The UNLV Rebels, coming off a loss to Santa Clara, take to the road this Saturday, as they face Azura-Pacific College.

APC Coach John Crandall was optimistic at the beginning of the season. An outstanding group of lettermen returned on both offense and defense. 'We have most of our top players back', said Crandall, 'And with their experience we've figure to be much improved.'

Crandell might have reason to be optimistic. Quarterback Bruce Priem, who racked up 1202 yards on total offense last year, is back, as are Chris Jones and Bob Storey. Jones caught 44 passes, including 8 touchdowns, and Storey had 45 pass receptions for 4 scores.

The defense features linebacker Dave Pentz, a 6-1, 200 pounder who last year accounted for 80 unassisted tackles and 60 assisted. Crandell considers Pentz the finest defensive player in small college football.

was seen on crutches after the Santa Clara game. We don't, at press time, know how serious his injury is, but his loss would definitely hurt the UNLV ground game. Gilchrist has run for 324 yards in his last three games, and has scored six TD's thus far. If he plays, we predict a two-touchdown Rebel win...if he does not play, we decline to comment.

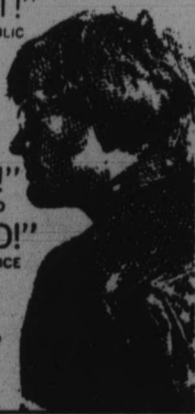

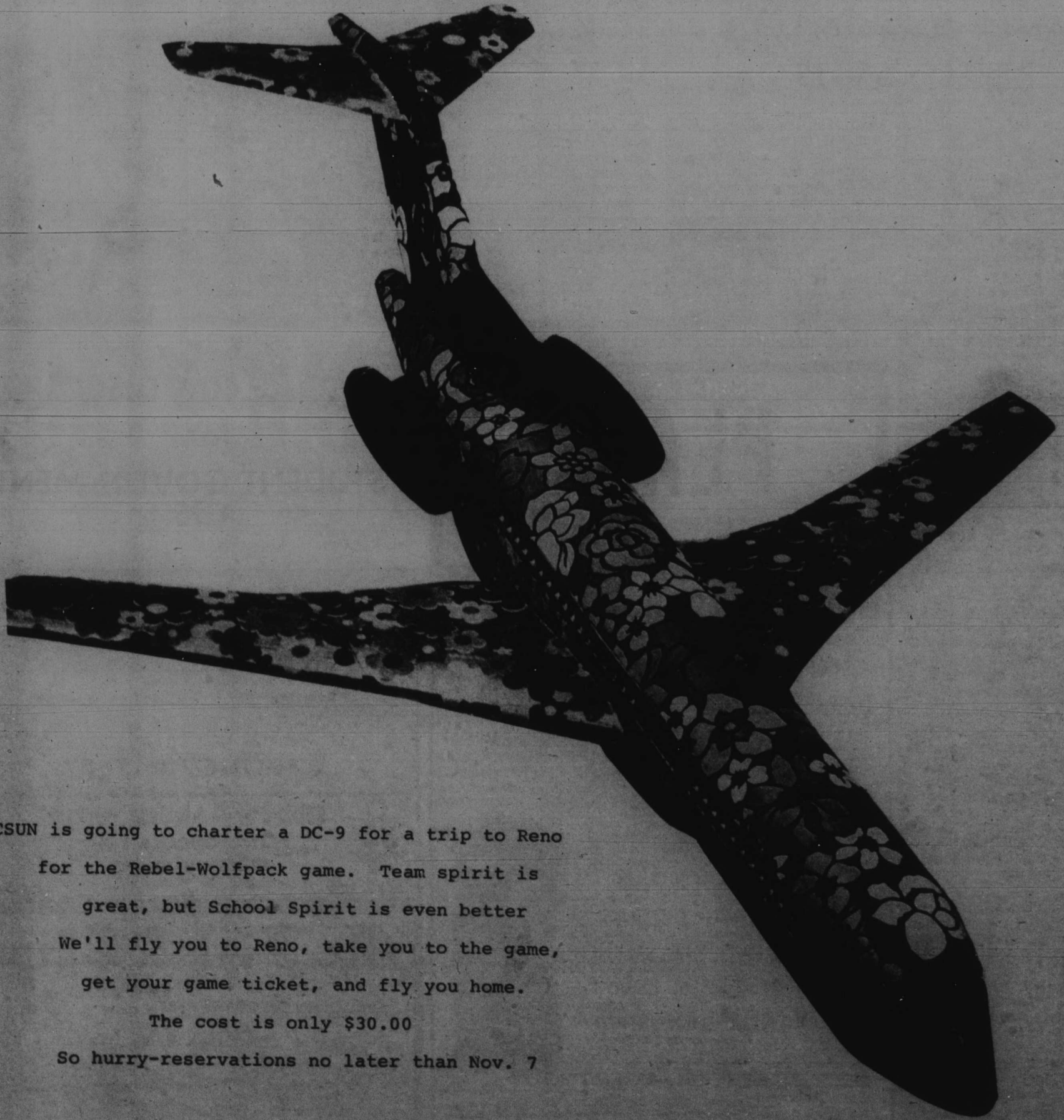
