Vivisection is such a multi-faceted industry and there are so many interpretations of all the various factions and there is so much propaganda that it is extremely difficult to get our message expressed

PAVE, for example, is not an "animal rights" group. If anything, we are a people rights group. Our message is this: Animal research is scientific fraud. It is killing people and it going to be outlawed.
