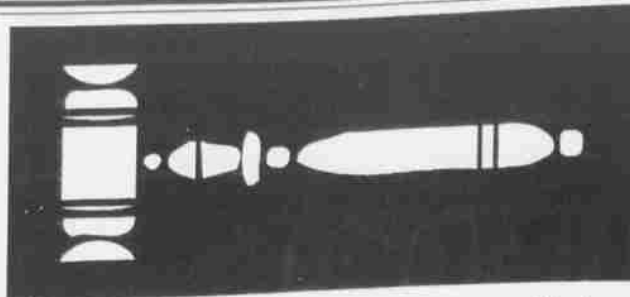

The last time we tuned into the senate, July 2, 1990 at 6:00 p.m., there was apprehension and doubt in the air: Would quorum be reached this time? By 6:12 p.m. all of our questions were answered as . . . the Gavel Fell . . . and Senate Meeting 20-21 was called to order by Senate President Gina Polovina.

The first order of business was to override the third unexcused absences of several senators. Approval of this motion would mean that three of our most prominent members, **Senators Benett, Colebrook and Ramsey**, would have their excessive absences excused and thereby remain on the senate. Well, it didn't happen that way; **all three were unexcused and removed from the senate** (Ramsey resigned prior to the meeting, however).

Next, Student Government President Bunin announced that **Vice-President Engle** is expecting (Congrats!) and will remain in office the duration of her term. The pregnancy will, in no way, interfere with her responsibilities (except for a little grouchiness now and then) as Student Government Vice President.

Senate President Polovina announced that **Senators Miller and Ramsey** had resigned earlier in the week so that quorum may be obtained in order to conduct business.

As legislation oftentimes goes, the remainder of the business was routine and uneventful. The only items of interest, other than the **encumbrance of \$75,000 to conduct normal business over the summer**, were:

- Approval of \$14,396 for new equipment and a storage closet for KUNV;
- Approval of three new senators: **Bernardi, Best, & Marshall**; and . . . well, that's about it for the interesting stuff.
