Tark issue flares up at Faculty Senate meeting

The Board of Regents meeting was the hot spot Tuesday, but the Faculty Senate had its own flare-up when senators argued over a motion made about the Tarkanian situation, the creation of an ad hoc committee on athletics and the recommendations made by the ad hoc committee on the status of women.

The Tarkanian motion, made by senator Ebrahim Salehi, called for the Intercollegiate Athletic Committee to investigate most aspects of the Tarkanian situation including point shaving, J.R. Rider and athletes' graduation rates among other issues.

The motion came at the end of the senate meeting and Salehi was criticized by other senators for not following proper procedure. Asked for the normal process of such a motion, Senate Chair Lori Temple said a

motion normally is submitted to the executive committee and then distributed to the senators for debate at the next meeting.

"There has been a lack of discussion on specific issues," Salehi said while the senate chose not to discuss his motion. The motion was sent to the executive committee for consideration after which it will follow the normal route.

Earlier in the meeting the senators discussed the formation of an ad hoc committee on athletics. At present, the intercollegiate athletic committee reports to the president. The new committee would report directly to the senate.

Sen. James Deacon, who supported an earlier motion to suspend the basketball program, said, "If it (the committee) is to be any good it's going to be controversial."

The recommendation passed 27-1.

The senate also discussed the recommendation by the ad hoc committee on the status of women. The main concern seemed to be the fact that members of the committee are to be chosen from people who are interested in the issue, and not elected by their college as members in other committees are.

Sen. Phillip Lowry said he was "afraid (the committee would consist) of old boys or old girls." Sen. Gerald Kops asked if this provides "a chance for an advocacy committee for men, for African Americans, for white Europeans?"

Kops continued, "Could we get a committee to address all genders?"

There was then an amendment made to have the committee members elected and it passed 20-11. The recommendation as a whole passed 31-0 with one abstention.

Swenson and Paradise may soon be one-way

It will be one way, or no way, for students driving in from the northwest side of campus after Clark County completes its plan to change Paradise Road and Swenson Street to one-way streets.

The county, in order to facilitate airport traffic and limit congestion on the intersections where Tropicana Avenue meets

these roads, plans to make both streets one-way, north and south respectively, up to Naples Street.

The plan was brought up in a February meeting of the Clark County Commission and was presented by Marty Manning of the Clark County public works department. David Hollenbeck, campus police chief, represented UNLV at the meeting.

Hollenbeck said he did not see how it would affect students greatly since there are still many access points to the Thomas & Mack Center parking lot.

"People will now have to take Paradise Road to Tropicana Avenue to enter on that street," he said, "but students could still go east on Harmon and then take Jerry Tarkanian Way."
