#### More readers respond to Berkley snub

I was astonished and dismayed to read that CSUN was recommending which candidates should be elected as regents. Personally, I was astonished by the recommendations. Moreover, I was dismayed that a government body would even attempt such a process.

With regard to the "handpicked" panel's selections, I personally disagree with two of the recommendations. First of all, passing over Shelley Berkley seems incomprehensible. As the first UNLV alumna in 20 years to serve on the Board of Regents, Berkley deserves more respect from her alma mater.

During my two terms as CSUN president, Berkley (a former CSUN President herself) served as CSUN's legal counsel at a rate far below what she could have commanded in the private sector. Berkley is probably the number one advocate of UNLV's interests on the board, and the students of UNLV should recognize when they have a friend on the

I also disagree with the panel's failure to recommend Nancy Price. Price was a classmate of mine while at UNLV. After receiving her bachelor's degree, she also went on to get her master's degree at UNLV. After serving as president of the Graduate Students Association, Price went to UNR to get her doctorate degree. In my opinion, Price's experience as a recent student makes her perfectly suited to receive the student's vote.

It is my opinion that Berkley and Price would make excellent regents. Obviously, not everyone agrees with me. That's the democratic process. What really disappoints me is that CSUN is trying to circumvent the political process by having five chosen students recommend who should be the next board members.

The purpose of a student government is not to endorse or recommend candidates for elected office. Student Government should provide the vehicle for students to get involved in events that shape their scholastic and extracurricular lives.

Elections, be it for regent or for president of the United States, impact the lives of UNLV students. Thus, it is CSUN's responsibility to schedule forums and debates between the candidates to allow UNLV's students to choose for themselves who should be elected. To hold a "closed door meeting" and handpick the "student's choice", belittles the students of UNLV.

CSUN should be commended for wanting to know what the candidates stand for and what each will do if elected. However, Student Government should stimulate debate and interest, not make

recommendations. Electing student leaders to recommend other elected officials misses the point of what a student government is all about.
