Call For Nominations

Faculty and staff are invited to submit nominations for the President's Outstanding Professional Staff Member of the Year Award. This annual award, which carries with it a \$1,000 stipend and a plaque, will be presented at a reception this spring.

To be eligible, the nominees (i.e., "A" contract, non-teaching faculty) must have been employed by UNLV as a full-time professional staff member since Jan. 1, 1988. Any member of the university community may submit a letter of nomination. Nominees will be notified of the nomination and given the option of submitting a one-page resume to provide additional information.

Nominations should address each of the six criteria listed below:

- Concern for the university and its goals, as well as those of the nominee's own department or division.
- Attitude toward fellow employees, students, and the public.
- Attitude toward work: availability, cooperation, courtesy, friendliness, helpfulness, presence on the job.
- Quality of work: accuracy, creativity, initiative, dependability, timeliness.
- Professional development: attendance at workshops, conferences and professional meetings; advanced degree work; presentation of papers and programs at workshops, conferences and meetings.
- University and community service: participation on committees at the university, in the community, and for professional organizations; community volunteer work.

Optional information might include outstanding achievements, other awards or recognitions, or any additional information to support the nominatioon.

Faculty and staff are invited to submit nominations for the 1992-93 UCCSN Board of Regents' Annual Outstanding Student Recognition.

Requirements:

- (1) Must be currently enrolled for at least nine (9) undergraduate or six (6) graduate credits at the University of Nevada, Las Vegas
- (2) Must be a student in good academic standing with their respective college (at least a 2.5 or above is required)
- (3) Must provide a nomination form from at least one letter of recommendation from either a faculty member, and administrator, or the president of the organization and/or department chairperson by whom the person is being nominated

Selection Criteria:

Those individuals who have made exceptional contributions in the following areas will be considered:

- *Academic Accomplishments/Record
- *Participation & Leadership in Academic & Extracurricular Activities *Citizenship & Service Contributions to the Community and/or University *Potential for Future Achievement
