ic. She did not come forward earlier because she did not want to be labeled a Tarkanian booster.

Titus also says she did not go to the media but was approached by them.

"I was approached by the press (*Las Vegas Sun*)," she said. "When they asked me if it was true, I certainly wasn't going to lie. I told them that I had gone to the EEOC and why."

Lori Temple, interim chair for the political science department, said she does not support the claims Titus has made.

"I've been here since May and I've seen no age or gender dis-

crimination," Temple said. "Everyone participates, classes have not been cancelled, and there is an equal distribution of funds. Everyone has equal opportunities."

Temple also says that Titus' classes were not cancelled.

"Those classes were never put in the schedule," she said. "If they were cancelled students would have signed up for them and then they would have been told that the class was no longer being offered. That never happened."

Temple and Titus both said they have seen conflict within the political science department.

"The political science department has a history of disagreement," Temple said. "People talk

about factions. When I came here there were clear allegiances, as in every department. However, those factions seem to be breaking down."

Titus said she feels some of the disagreement within the department can be attributed to her: "I feel like it's happening because of me."

The EEOC will begin their investigation by getting the facts from both parties. Once this has been done a settlement will try to be reached, if a settlement cannot be reached the matter will be taken to court.

Titus said she won't know if she is going to fill a lawsuit against Maxson until the EEOC completes its investigation.

ed with the advisory board asks that the OSI page be eliminated and the paper be permanently allocated the 8.75 percent.

"To me the issue is whether UNLV should have an independent paper and is this a legitimate amount of money for students to contribute," said Ched Whitney, the editor in chief of *The Rebel Yell*. "Obviously, I

think the answer is yes."

According to Benneman, the Senate will pass the version he wrote but not the version amended by the advisory board. "That won't fly," Benneman said. "I guarantee if won't fly. The one I wrote, with the OSI page, that will fly."

Benneman said the Senate perceives issues like the OSI page as an example of selfishness on the part of *The Rebel Yell*. "It's student fees that started the paper," Benneman said. "With-

out the OSI page it's just take, take, take. They (the senators) see it as a student information page."

Whitney said the OSI page amounts to propaganda because it serves Student Government and not necessarily the students. "I think its counterproductive for a student newspaper to be beholden to any government agency but I think it should be 100 percent accountable to the students."

Whitney also said that while *The Rebel Yell* may not be perfect, its existence is important to the university and that should be the basis for the Senate's decision.

"Any individual problems a Senator has shouldn't factor into the decision," Whitney said. "Nobody's going to argue that *The Rebel Yell* doesn't need to improve but it's current makeup, with the advisory board, gives it the stability to experience growth and improvement."

Student Body President Joel Kostman said he is in favor of Benneman's resolution which he called "the most realistic one and the fairest one." Kostman did not have a problem with the resolution because of the provision in one of the resolutions

that guarantees editorial control.

Some believe the make up of the new advisory board could be controlled by one interest group.

The board will have five undergraduate students, one senator, two outside media professionals, one member of the paper and one person from University News and Publication Office. The possibility exists that the board could be stacked against the paper.
