 expected parking problems to "ease up a little" this year. However, just within the first week eight vehicles were ticketed and towed for parking problems in the Brussels Road dirt lot, and there were six accidents in various parking lots around campus.

He emphasized that students would be better off using the Thomas and Mack parking lot. Said Drake: "You don't have to walk any further than if you park by Tropicana," Drake explained. "It's a lot safer. The Thomas & Mack is the best lit." But for those who chance the system and get caught, there

has been a change in where ticket fines are being collected. Students will now be paying at the Department of Public Safety instead of the cashier's office. Drake said the change was made to somewhat relieve the long cashier lines and to make it easier for University Police to check the payment of the tickets.
