Pam Littleton, an older graduate student in the program, said she was, "very disheartened" by the controversy.

"The biggest problem with this program is all the hearsay and gossip. It's getting so out of hand."

Soyeren said, "the problem here is mainly Hugh Burgess (Chairman of the architecture program) and Richard Beckman (Assistant Professor of Architecture) who are the main responsible and dishonest people in this game here."

Said Soyeren: Burgess is an "intruder into the profession." Soyeren claims Burgess is an incompetent teacher because he lacks the proper credentials, such as a bachelors in Architecture.

The truth is Burgess has a bachelor degree in English, but he also has a masters and doc-

torate in architecture from Columbia and Rice, respectively.

Soyeren claimed that Burgess was forced out of Arizona State University, where he was Dean of the College of Architecture. ASU hasn't been contacted to verify this, nor has Burgess addressed the issue.

Soyeren accused Richard Beckman of cheating the university payroll when he received \$50,000 for duties that a part-time faculty teacher would be paid \$3,000 for.

"What does that tell us," said Sanders. "We can go down to the library and look up every professor's salary in the school. So what?"

"I don't care how much he gets paid (because) whatever they're paying him is worth it because as far as (Beckman's) credentials, I think they're flawless, and as far as a design teacher, he's one of the best I've ever had."

As for the so-called "Phantom Faculty" listed in the architecture brochures, Burgess said it was a case of Soyeren; "looking at the veneer and drawing vast conclusions."

Though he lives and teaches in France, Nouvian is still listed as a faculty member because, said Burgess, he conducts UNLV's extended program in Europe.

Ozguner, another professor listed in the catalogue, was scheduled to teach in 1991 when he withdrew because of a major commission he had to complete in Turkey.

In fact, said Burgess, Ozguner was scheduled to take Vefik Soyeren's place in the department.

**New directors appointed at senate meeting**

At the first Student Senate meeting of the fall semester, on the motion of Sen. Brad Jackson, the senate appointed three new directors and approved their stipends.

Patrick Smith was appointed as the new Nevada Student Affairs Director, Danielle Rapuano was appointed as the Office of Student Information Director, and Michael Aloyian was appointed as Elections Board Director.

Smith, who stepped down from the senate in order to assume the NSA directorship, will receive a \$300 monthly stipend while in office. Rapuano will also receive a \$300 monthly stipend. Aloyian will receive a salary that will vary between \$150 and \$300 between September 1993 and April 1994.

"Some people had some concerns about Pat Smith coming in after Mike Kennedy had been NSA director and an executive board director, some big shoes to fill, but Sasquatch (Smith) here has filled them pretty well," said Joel Kostman, student body president, about the new NSA director.

Ed Marshall, the organizations board director, announced that he wanted to create a new, smaller committee to work alongside the already existing organizations board.

Marshall said, "there's a great big bunch of people, but they all have a voice on the board."

If approved, the committee would be called the organizations council, and would have a small number of members, each of whom would represent a constituency of related organizations. The organizations board currently meets every other Thursday. The Organizations Council, if established, would meet on the

opposite Thursdays.

Other business included: Entertainment and Programming Director Jami Nalder promoted a Student Government-sponsored Reggae Jam. The four-hour event, which was last Wednesday night in the MSU Courtyard, featured free beer, nachos & cheese, and pretzels.
