# Georgetown Dean promotes law school to UNLV students

Law school hopefuls gathered at the Tam Alumni Center last Saturday morning for a discussion by Andy Cornblatt, Georgetown Dean of Admissions, on how to beat the admission process.

Dressed in suits and ties, the group of 21 students listened to Cornblatt, who is on his annual tour to promote Georgetown's program.

If the UNLV students decide to apply, they will be part of a pool of 9,000 applicants to the acclaimed law school. Of those, only 650 will be accepted.

Cornblatt explained there is no easy formula for deciding who gets into Georgetown and who doesn't.

"I don't want to give you the impression of some sort of certainty," because the selection process is not an exact science, he said.

The decision is based on six criteria which are divided into three areas: Grade point average; LSAT scores; personal statement, letters of recommendation, work experience and activities. Each area carries roughly a third of the weight.

While GPA and LSAT scores count heavily, Cornblatt empha-

sized the Georgetown selection process, unlike other schools, is a non-numerical one, since they take into account many variables.

Said Cornblatt: "Medium GPA's don't mean zip. Somebody with a 3.0 who's working 40 hours a week, who's taking difficult

should give the reader a feeling for the student's "ambition, creativity and sense of proportion about life. The more I can get to know about you, the better," Cornblatt said.

He described the writing of the personal statement as "a miserable job."

"You have to sum up your life in two... pages," he said. "You're going to hate writing it, you're going to hate me, and if you're feeling all those things, then you're doing it right."

As for testing, Cornblatt admitted that some scores do not reflect the student's ability, and "the best way you can get me on your side on this is to write a personal statement."

On the other hand, he said anyone with an LSAT score below 150 will "have a tough time getting in."

Cornblatt suggested that students get their applications in by the middle of November, Thanksgiving at the latest.

As for his visit to Las Vegas, Cornblatt emphasized that his presence here is "designed to tell students that Georgetown is looking for applicants from across the country, especially from areas where we have not gotten many students before."

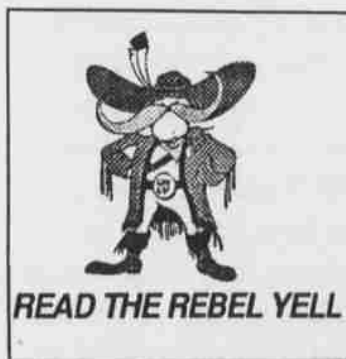
## Canned food drive to help the needy
