Senate elections director criticized

Senate President Pro Tempore William Romero led the Senate for the first time at last week's meet-Senate President Bud ing. Benneman ordinarily conducts the meetings, but he and Student Government President Joel S. Kostman were out of town. Romero has held the position for over a year, while also chairing the Senate Bylaws Committee.

The Senate meeting was short, but a number of Senators were continuing to question the printing of extra ballots for the last election. The round of questioning began with Sen. Scott Fisher, Business and Economics, posing the question, "So, why were there 18,000 extra ballots?"

Elections director Mike Aloyian responded that the board was not sure where the responsibility lay. Aloyian noted, "Bud Benneman gave the final count to quick print."

Fisher continued, "Bud's been around long enough to know that we don't need 22,000 ballots."

Aloyian added, "In each college we went about 150 over the counts."

Sen. Joe Martin continued the inquiry, "So, do you have a total number for the election?"

Aloyian responded, "Laurie [Snyder] would have that number.

Sen. Walter Vodrazka, Engineering, questioned, "Who put down 3000 ballots for the Engineering college Wednesday morning?'

The Elections Director noted, "That was just a mistake."

Aloyian thanked all of the candidates who ran saying, "Well, as they say, out with the old and in with the new. This election possibly set a record vote. To those who went out there and did their best, it paid off."

Entertainment and Programming Director Jami Nalder thanked numerous Senators for their assistance at the last football tailgate party. Nalder commented about the number of attendants at the party: "There were not quite as many as there were at the first football game."

Nalder added that she had promoted the party as best she could. She made this observation about the decrease in party-goers: "I lay the blame on the football team's record."

Also, this year's homecoming court will be announced at the annual Rebel Rally, Nalder said. The Rebel Rally will start tomorrow at 10:45 am and continue into the afternoon. The names of the homecoming king and queen will remain secret until the time of the actual game, however.

Sen. Stephanie Boixo, Liberal Arts, and Sen. Helene Pobst, Fine and Performing Arts, contended for the Student Senate's seat on the Rebel Yell Advisory Board.

Boixo made her case for the seat by saying, "The newspaper is a very important part of the university. It is important to have a legitimate Rebel Yell Advisory Board. We need to make the paper a better thing."

Pobst stated, "I care about the paper; I'll be there at all the meetings. Somebody's got to be there to watch over all of the money they spend."

Sen. Joe Martin, Business and Economics, questioned Pobst. "You're fairly outspoken about the paper. I'm kind of concerned about Senate censorship."

Pobst responded that she would not engage in any censorship and her role would be one of "making sure they spend money thriftily.'

The election of the Rebel Yell Advisory Board seat was by roll call vote. Boixo was chosen to represent the Student Senate. The count was: Boixo, eight; Hobst, four; and three Senators abstaining.

NLV ranked in top third

The University of Nevada, Las Vegas was ranked in the top third of 113 western colleges and universities rated by U.S. News and World Report's annual "America's Best Colleges 1994 College Guide.'

UNLV was ranked 35th, according to Robert Morse, director of data analysis for the guide, placing it in the second quartile of regional universities in the West.

Previously, UNLV was listed for four consecutive years in the guide's "up-andcoming regional university" category, a classification the guide no longer uses.

To arrive at this year's ratings, U.S. News analyzed academic reputation ranking was based on the evaluations provided by other university presidents, deans, and admissions directors.

"We feel this is another encouraging report on the progress UNLV is making," said UNLV President Robert C. Maxson. "Again, we have received validation from both

and academic reputation. The our peers and from another college guide that we are academically competitive. It's certainly an honor for a university that was established just 36 years ago to receive this kind of recognition."

UNLV was also recently included in the 1994 edition of the book, "101 of the Best Values in America's Colleges and Universities."
