significant contributions to the university, and I am confident that he will continue to do so as a teacher and a scholar," Guinn said.

University Regent Shelley
Berkley said "It saddens my
heart. I've known John Unrue
since I was a student at UNLV.
This entire controversy is a tragedy, but it's time for a change.
The next provost will be able to
build on what Dr. Unrue has
done."

Unrue said he reached his decision to resign well before the Monday announcement, and cited both personal considerations and a desire to return to scholarly research and teaching as his

"My family and I reached this decision several weeks ago," Unrue said. "The job had become far more stressful than it was fun, and in my 25 years at UNLV, I've never had a sabbatical, ...a leave of absence, nor have I had an opportunity to pursue the scholarly interests which I think are very important."

The furor over alleged irregularities in Unrue's travel expenditures peaked this past weekend after a story appeared in the Las Vegas Sun concerning the issue.

Nevada Senate Minority Leader and UNLV political science professor Dina Titus, D-Las Vegas, and University Regent Berkley called for Unrue's resignation.

When asked about specific differences with Guinn, Unrue said he preferred to "leave his statement in general terms," adding "I think it very correct that Dr. Guinn should have a provost who is entirely compatible with his views. I also concluded some time ago that my priorities and my concept of what UNLV should be would probably make it impossible to remain here."

As provost, Unrue exercised control over some discretionary accounts, including a travel expense account. He authorized payments totaling \$20,000 for his own travel expenses, a sum far exceeding the travel budgets of entire academic departments.

Denying any irregularities involving his travel expenditures, Unrue said "There is no abuse of power at UNLV with respect to travel, and any accurate comparison of my travel with the travel of provosts at the sister institution (UNR) would most likely reveal nothing extraordi-

nary or irregular."

Responding to Titus' and Berkley's calls for his resignation, Unrue said, "The so-called revelations which have been alluded to in the October 10 Sun article, will be perceived by most people who know the facts to be an orchestration and a contrivance calculated to discredit. Everybody on campus knows what's going on here."

He added that Titus, in particular, had opposed him for a long time, and that "virtually no one at UNLV should be surprised that she would call for my resignation." Unrue also took issue with Jeff German, a Las Vegas Sun reporter, suggesting that he cooperated with Titus and others to force his ouster.

"It (the alleged collaboration) was simply looking for something to try to discredit me with," Unrue said."There was a reference some weeks ago in German's column suggesting that 'administrators' need to have their travel audited, and I think there's a relationship there."

Titus responded to Unrue's comments. "An administration characterized by incompetence, fiscal irresponsibility, and abuse of power will eventually fall of its own weight," she said. "To suggest there was a concerted effort (to discredit) is ridiculous. If Unrue had not spearheaded a vendetta against me in the 1991-92 academic year, I would have been less vocal in my opposition to his continuance in office."

German on Wednesday dismissed Unrue's claims, and said "He's the one who did the jetsetting. If he hadn't been doing the travel, I wouldn't have had a story."

Unrue said the prospect of returning to the classroom appeals to him. He noted that he did not consider his move to be a demotion, and added he looked forward to teaching again. "I'll be honored to return to this faculty and to do what I consider to be the most important work on campus, and that is to teach and to prepare for the classroom," he said

Unrue's current \$120,000 peryear salary will be reduced to not less than \$96,000 per-year when he returns to the classroom.

Guinn replaced Unrue immediately, and appointed Dr. Ron Smith, dean of the Graduate College, as interim provost. Dr. Cheryl Bowles, associate dean of the Graduate College, will serve as interim dean of the Graduate College. Both appointments became effective Monday.
