**October 19, 1994**

 that'll get him a high-wage job at a very early age," Gibbons said.

This program would be funded by the companies who are enrolled in it. Gibbons said about 12 companies, including International Game Technology and Mallory Corp., have agreed to participate in the program.

Gibbons said he wants to eliminate parole for violent criminals in Nevada. He said the way to accomplish this is by imposing alternative sentences on non-threatening offenders, and by enforcing "truth-in-sentencing" to make sure violent criminals serve their full sentences.

Gibbons said violent crime would be lessened by stronger enforcement of the death penalty.

"Whatever you can say bad about the death penalty, that it doesn't deter crime, I say 'nonsense,'" Gibbons said. "I think the problem with our death penalty today is that we don't enforce it. We have not had one person sentenced to death go to his ultimate destination in the last six years. Why?"

Gibbons said another way he would prevent the early release of violent offenders is by opening the Lovelock prison.

Gibbons criticized Governor Bob Miller for neither opening, nor leasing out the prison. Gibbons said three states have offered to lease the prison for a cost of \$45 million over three years. He added that the federal government offered to buy it for \$65 million. Gibbons said since the

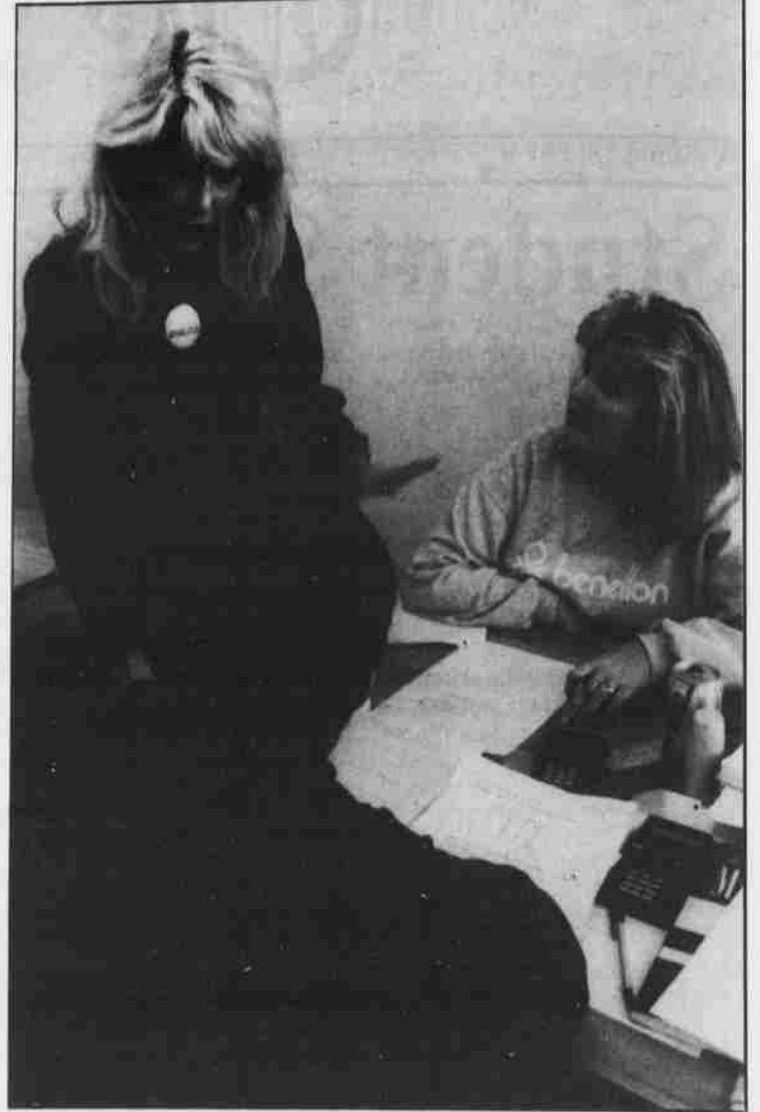

prison cost \$45 million to build, Nevada could lease it for three years, get the prison back, and then have a prison that cost taxpayers nothing.

Gibbons said there are many reasons he would make a better governor than Miller. Gibbons' reasons included charges that Miller never held a job in the private sector, never had to meet a payroll, never had to "create a dollar" and doesn't know where Nevada's going economically.

A poll released last week by the *Las Vegas Review-Journal* showed Miller was leading Gib-

bons by 9 percentage points. Gibbons said he was confident that he would close the gap by election day.

Gibbons said name recognition is crucial to getting elected. The R-J poll showed that 9 percent of the 817 registered voters polled didn't know Gibbons, while everyone recognized Miller's name.

"I committed to this race because I'm tired of what I see in government, and I want to make a change," Gibbons said. "But I'm not threatened by the outcome."
