officials from paying any type of parking fines.

Boixo reiterated her thoughts that she was not responsible for the tickets. "When I walked out and saw the boot on my car, I said 'I'm the student body president, how can they put a boot on my car?'"

When asked if he knew about the boot, Ackerman said he didn't recall her mentioning it.

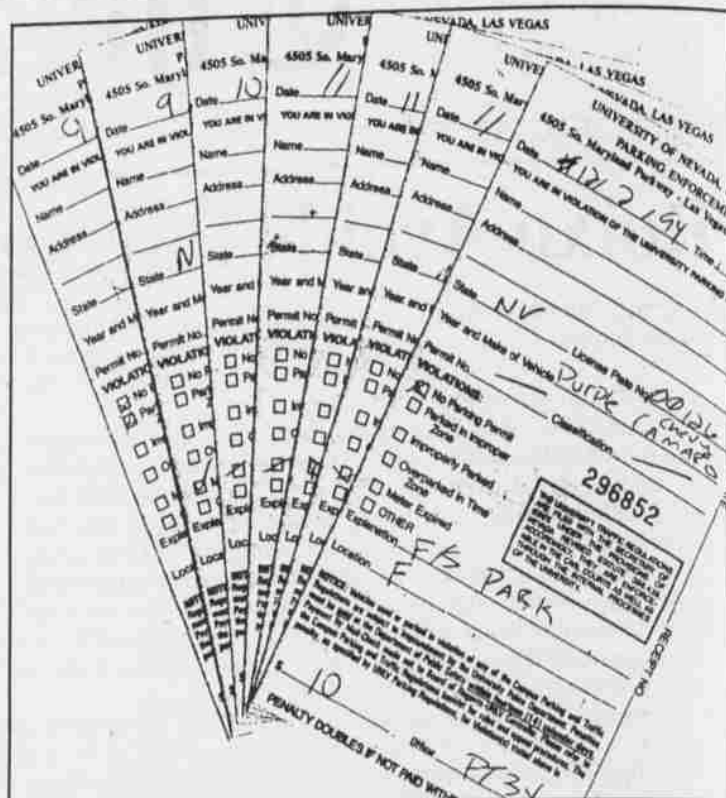
Boixo claims she mentioned the boot to Ackerman in a conversation they had the day the device was placed on her car.

At press time, Boixo still had not paid her fines and didn't plan on doing so.

"I honestly don't think I should have to pay the fees," she said. "I'm not going to go in and just plunk down a check for \$230 for fees I don't feel I'm responsible for."

When a student has excessive parking violations, registration privileges and school records are put on hold. But Boixo was able to register for her spring semester classes without paying the overdue fines.

Boixo received her fifth ticket on Oct. 26, 1994, but was still able to receive her fall grade report and register for spring class-

es. Boixo claims that a hold has been put on her university account.

"All of my graduation papers are on hold because of this," Boixo says. "I don't know how I was able to register this semester."

While Boixo is quick to blame other parties for her ticket problems, Ackerman feels the blame lies squarely on her shoulders.

"I'm disappointed in Stephanie," he said. "I don't have the power to fix tickets and I certainly didn't do so in this case."
