Monday a stu-dent senate committee investigating the parking ticket problems of Student Body Presi-

dent Stephanie Boixo cleared her, as well as two other administration officials of any wrong-doing.

Boixo admitted she called Ackerman about the fact a boot was placed on her vehicle. Before the story ran she was quoted as saying she "honestly didn't think she should have to pay the fines."

She admitted she did not sign her promise-to-pay form as required by Public Safety until after the story ran. Boixo said she didn't think the fact she had received seven parking tickets was a "big deal" and if she had just paid the tickets none of this would have happened.

Really Chief Hollenbeck said he didn't think the tickets were public record, however, the state attorney general's office says otherwise. A memo was circulated through the department about not releasing tickets or copies of tickets to any-

one in the future. Hollenbeck questioned who in the attorney general's office had been contacted, because he didn't think the information was correct. When told, he felt proper procedure had not been followed.

Really According to the testimony,

four of five parking procedures had been ignored or followed improperly. Why didn't Boixo sign her promise-to-pay? Because a student worker in the parking enforcement office told her, on no authority but her own, not to.

Sen. Terry Moore went so far as to accuse Scott Gulbransen of "causing the whole thing without any proof at all." Boixo said the "yellow journalism practiced by the Opinion Editor was unfortunate."

Because the senate wants to get this behind them they will consider this the end of the matter. The students of this university, however, were shortchanged. Many questions that should have been asked by committee members were not asked.

If she was told she didn't need to sign it, why did she?

The senate decided to implement some new procedures regarding its internal parking policies as they apply to CSUN officials as a result of this matter. Good idea.

One suggestion, which was rejected out-of-hand by Boixo at the beginning of her term, is to let CSUN officials get a parking sticker and find parking just like everyone else. This would not only allow parking officials to know who is parking on campus, it would also help CSUN officials remember they were elected to serve the student body, not take advantage of a position of power.
