Are Nazi Symbols Really Necessary to Make an Artistic Point? A recent visit to the art exhibit Das Pop in the Donna Beam Fine Art Gallery proved to be both provoking and disappointing. The


works of one artist in particular made the experience somewhat depressing. The works of Joe Allen include Axis Bold as Love and Victory Lane which both, incidentally, use the swastika as a focal point.

The Das Pop brochure cites that the purposes of the exhibit are to "simply assume that we live in one culture" and that "the artist's task is not to play one ideology off against the other."

Obviously, if a swastika is used, ideologies are being played off against one another. Why would anyone assume that college students necessarily want to support art, with their tuition dollars, that purports the false idea that we all live in "one culture?" Didn't Adolph Hitler want everyone to be part of one culture?

Obviously, the ideologies of dead American veterans, Jews and many others from World War II doesn't mean much when it comes to "the synthesis to mitigate both the rarefied elitism of 'high art' and the commercial rapacity of 'popular art."

The questions that should "pop" into every student's head at this point is "Do we really need Nazi symbols to make a point about art at our school? Are our rights as students being violated by art being forced on us



that we neither choose nor support ourselves? Where do we draw the line in the Donna Beam Fine Art Gallery

KKK art? The point is not how often this symbol is used somewhere else, but rather the principle that our tuition dollars should support an environment free of any persecution symbology.

The seriousness of the question requires much thought and a look at the intentions of the artist, Joe Allen.

Allen stated "It was an experiment to see if the swastika's image could be detoxified and it didn't work. The intention is to get an effect and if art doesn't get an effect, its boring."

If the idea that UNLV is being used as an experimental lab to see whether the swastika's image can be changed doesn't annoy you just a little bit, try the insensitivity of using the symbol even though you already know it is going to upset many people.

Allen stated that he chose the swastika "because its the most powerful symbol in the history of western civilization." Setting it in flowers does not detoxify the image of the swastika because "the image is so powerful it cannot be camouflaged."

Allen put the swastika in the television for Axis Bold as Love in an attempt "to put it into the same medium as MTV."

Great, an attempt to help college students familiarize MTV with the swastika. What kind of

person would think that this is going to "detoxify" the image of the swastika?

Granted, the swastika was once a symbol for Indian and Tibetan peoples and had nothing at all to do with mass genocide.

However, there was this little event called World War II and, unless everyone's memory is incredibly short, the image of the swastika cannot (logically) be detoxified in only 50 short years.

Maybe logic is too much to ask for.

Allen even took the time to pleasantly describe Dave Hickey (UNLV Associate Art Professor and art critic) and Hickey's observation that "people got mad" when certain symbols were used "in a pleasant way" or in a pleasing scenario.

Allen elaborated on the intention of Axis Bold as Love and Victory Lane by saying "I think that if you interpret it as trying to make the swastika beautiful you only get half the way there." Allen defended his so-called

art work with "I'm not doing this to offend anyone, but neo-Nazism is kind of on the rise."

Allen even graciously noted that "the people in the Israeli Consulate at the Embassy in Houston had some complaints."

Allen's intention to stir controversy is apparent when he stated "I don't know if they think I'm cashing in on the issue, but I don't think its possible to trivialize the image. It would be acceptable for me to take the swastika and make it ugly. If you put it into a beautiful context, it stirs people."

A university should be a place where students can feel comfortable at all times. It is not a place for experimenting with symbols that represent genocide and mass destruction. If it is, when do the KKK paintings arrive for the sake of experimenting whether those images can be "detoxified?"

Are your rights as a student being impinged upon when you cannot go into the Donna Beam Fine Art Gallery without being offended?

Is it a new UNLV policy to sacrifice the feelings of students for the sake of art?

ident Salinas make a fool of himself while fleeing his country after allegations of his involvement in that murder. These are hardly signs of a sta-

ble, or corruption free government.

Recently the newly created peso, which many US. and Mexican economic advisors thought was overvalued, fell to less than half it's value in a few months and is still falling. Part of the blame is NAFTA's short-sightedness in thinking by raising the wages several fold and creating a new higher value peso everything would be fine. Common sense tells us that you cannot fool an economy into thinking it's worth more than it is, and likewise the inflation rate is currently over 90-percent, with in-terest rates at a mind-boggling 100 percent or more.

Newly elected President Zedillo has declared a state of emergency and is proposing measures to increase the value of the Peso at all cost.
