
We must remember this tragedy and the pain it created. Hopefully it will make our own nation think twice about our own bombing and our role as world police-

## Even If Aquitted, O.J. Won't be Free

Many have called the O.J. Simpson case, "the trial of the century." I call it the murder case that just keeps killing.

O.J. Simpson probably will never be executed if found guilty.

But even if the jury acquits him or is hung, Simpson will emerge damaged beyond repair. He will be broke, and a pariah in the worlds of sports endorsements, broadcasting and movies - which made him rich and famous before the brutally slashed bodies of his wife Nicole and her friend Ron Goldman were found.

Mark Fuhrman, the detective who allegedly found the blood on Simpson's Ford Bronco and the "bloody glove" on Simpson's property, might find his future fatally circumscribed. Despite the view of some that Fuhrman has won a courtroom duel with F. Lee Bailey, Fuhrman might have dug himself into a black pit of perjury when he testified flatly that he had not used the word "nigger" during the last 10 years, or that racism and hatred of romances between black men and white women never influenced his police work.

The whole Los Angeles law-enforcement establishment has been dealt some crushing, if not mortal, blows by evidence of sloppy, suspicious work that is likely to leave millions of people believing it has engaged in a tunnel-vision effort to convict Simpson.

Millions of Americans are lashing trial Judge Lance Ito as a weakling who tolerates a circus, and as a former prosecutor with a policewoman wife who blinks at atrocious police and prosecutorial activity. Appeals courts will decide whether Ito "got killed" professionally by this trial.

Perhaps Faye Resnick, Nicole Simpson's "friend" and current best-selling author of a sleazy book about Nicole was in a "dead end" life before this trial, but courtroom claims about her use of drugs and her overall level of

morality and credibility could cause her to wish she were dead.

Then there's the dogged prosecutor, Marcia Clark, victim of the anger of an exhusband who accuses her of child neglect because she is working so desperately to win a conviction in the most publicized murder trial in history. Not only could she lose sole custody of their children, but she has become the target of triggertongued right-wingers who say a woman's place is with her children and her cooking pots.

And how pathetic the symbol of the living dead, attorney Robert Shapiro, who sits through every trial moment like a zombie. He manages only an occasional show of life, as when he undercut Bailey and told the news media that the issue of race should never have been injected into the defense.

Lastly, let me say that this case has become a dagger in the heart of the American media — the supermarket tabloids, the New York tabloids, the dailies that supposedly ponder what's "fit to print," the television stations and networks that rush to spread every rumor and innuendo. The media offenders won't die, but those who value press freedoms and protections tremble from an overdose of irresponsible behavior.
