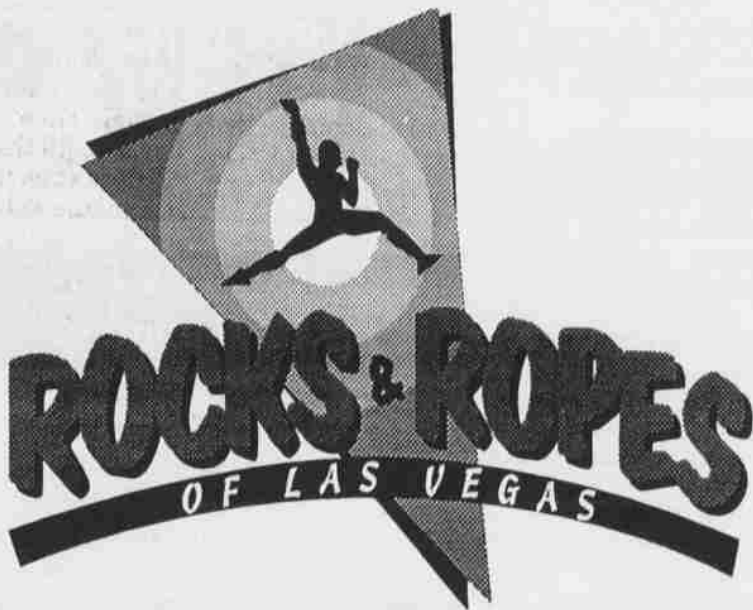

Rider Locked Up

Ex-Runnin' Rebel hoopster Isaiah Rider spent four days in a Minnesota jail last week.

The current Minnesota Timberwolves star guard violated terms of his probation on a 1994 assault conviction.

County District Judge Dolores Orey in Minnesota put Rider behind bars on Wednesday for failing to stay in contact with his probation officer.

Rider has had problems with the law since his days at UNLV when he caused a controversy at a local Jack In The Box fast food restaurant.

Rider reported to the county's Adult Detention Center shortly before 7 p.m. Wednesday as ordered. He was in custody until Saturday morning.

Golf coaches sued

A former member of the Rebel Golf team has sued two coaches and the Board of Regents for alleged racist comments made by assistant golf coach Jim Higgins.

David Lee, a student from South Korea, claims that Higgins made racist public remarks about Lee's Korean ancestry. In the lawsuit filed, Lee says that head coach Dwaine Knight and Higgins caused him emotional and psychological stress.

Also, Lee claims in the lawsuit that Higgins called him a "nip" and made comments on how Korean people eat cats.

The plaintiff is now enrolled at California-Berkeley, and is seeking compensatory and punitive damages for the harm the remarks did to his golf career.

Knight was named in the lawsuit for not correcting Higgins after clearly hearing the racial slurs being made.
