Regent proposes fee waivers for athletes

Regent Mark Alden told the Student Senate Monday that athletes on campus should receive registration fee waiv-

Alden also explained his reasoning for voting "no" on the UNLV law school study request during last week's Board of Regents meeting.

"I believe that any student competing at a university or

college in Division I athletics should be afforded the opportunity to have a tuition wavier," Alden said. "Good strong athletic programs do nothing but help the university."

Alden added that with the potential of future tuition increases, a strong athletic program could offset some of those

Alden said that other Division I schools such as New Mexico State and Stanford offer fee waivers for their student athletes and the time had come for UNLV "to step up to bat.'

"People in my college would like to have that privilege too," Sen. Leia Fleischman (Fine Arts) stated, questioning the fairness of Alden's proposal.

Alden responded that student athletes serve a variety of roles, and deserve a form of compensation. "These stu-dents are really giving something up," Alden said.

Alden also explained to the

Senate why he voted no on the \$500,000 law school feasibility study last Friday.

"There are so many unmet needs on campus," Alden said. However, he said he would respect the wishes of the majority.

Alden also encouraged members of student government to run for a seat on the Board next year to make the regents more representative of students.

Titus tells all

UNLV does TREE OCK law school, Sen. Dina Ti-tus, D-NV, said Tuesday at a UNLV press confer-

"I'm not in favor of a law school at this point in time," Titus said. "I hate to see resources that are already in short supply go to an elite division. Resources need to go to strengthen existing programs.

"Furthermore, it really doesn't make a whole lot of sense to put a law school down here and a medical school up north, it should be reversed," Titus said.

According to Titus. UNLV is better suited for a medical school because Las Vegas has several large hospitals. The University of Nevada, Reno is better equipped for a law school because a Judicial College is located in Reno. Titus said.

Titus, who is also a fulltime political science professor at UNLV, takes a leave of absence every other year during the spring semester to attend to her senatorial duties in Carson City.

"It's really two full-time jobs, but it keeps me out of trouble," Titus said.
