Patricia Limerick, a history professor at the University of Colorado, will present "The Atomic West" Monday at UNLV.

Limerick, author of *The Atomic West and Encounters with the American Deserts*, will describe the ways society and politics in the western United States were shaped by science and technology policy in the post-World War II era.

"The Atomic West" is the second lecture of "Nevada In The Nuclear Age," a year-long series on the scientific, philosophical and social concerns of the nuclear era.

More than \$21,000 in Grant-in-Aid and Student-Access funds are available through the Greenspun School of Communication to communication studies students.

Eligible students must hold a cumulative grade point average of 3.0 as of the summer semester of 1995, and attend UNLV full-time for both fall 1995 and spring 1996 semesters. Students who have already received a scholarship through the Greenspun School for the 1995-96 school year are ineligible.

To apply, students must sub-

mit one original and one copy of the following: application form (available in the main office of the Greenspun School, FDH 452), their current UNLV transcript and a one-page 1 statement about their academic and professional goals. Optional materials included class papers, creative projects and professional goals.

Applications must be submitted to the Greenspun School main office by 5 p.m. Friday. Award decisions are made within four weeks. For more information call Erika Engstrom at 895-3639.

Dilan Goshorn, a human resource management student, said, "It's a good opportunity because you don't have to fly to all of these places to get this information."

Al Gourrier, a senior majoring in finance, agreed. "It gives students exposure to universities they wouldn't otherwise be introduced to.

"We get short-changed at UNLV because there's nowhere to get information about (law) schools," said Gourrier.

Many students who attended the forum acknowledged the need for a law school at UNLV. "It's long overdue," said UNLV graduate Alex Yanez. His brother, Abel Yanez, a senior majoring in secondary education at UNLV, said he "would definitely consider going to UNLV's law school, if they had one."

The forum was held from 10 a.m. until 2 p.m. and was sponsored by UNLV, Community College of Southern Nevada, and the Western Association of Pre Law Advisors.
