Neil started to specialize in this branch of the law, when he first was admitted to practice in New York City after graduating from Columbia University Law School. Like other lawyers he is a member of bar associations in the county and state where he has been practicing but unlike other attorney's he became president of Western Trial Lawyers Journal, and treasurer of the Workman's Compensation Section of the national organization.

As a foremost authority on accident litigation, he knows most of the answers to the questions we all are asking ourselves: Why must there be so many accidents and what can we do to prevent them?

"Accidents don't happen," insisted Neil, "they are caused by thoughtlessness of people."

"The sad circumstance," he continued, "is a person of normal earning power, suddenly being victim to an accident. Medical bills, loss of weekly income, rehabilitation requirements, all could casue a financial breakdown in a family that otherwise had managed to maintain a happy level."

That is why Galatz is a foremost advocate for compulsary liability insurance covering no less than \$20, 000 for each person with a claim and \$40,000 for each ccident, "We need it in this area, to protect the innocent." Galatz claims.

As the law now stands, financial responsibility commences only after the first accident.

Galatz leaves no stone unturned in his quest to determine the cause of an accident and thereby he comes up with logical conclusions in fixing the blame. After a number of accidents were reported across the country involving a certain make of car manufactured from 1961 to 1963, Galatz embarked on an extensive research. He is conclusively certain the cau-

se of the accidents in these particular cases was due to inadequate suspension and weight too far forward in the specific model automobile.

Hundreds of cases are pending, and many have been settled out of court, but Neil's deductions have yet to be disproven.

All his life he has been making up his mind quickly and displaying a determination to follow through.
