Jewish refugee families was concerned, was wasted if you accept support from the Birchers. By doing so you lend credence to the lies of leading Birchites, like Dr. Reville Oliver, who stated the LSD drug was imported from Israel, that the Nazis did not kill 6,000,000 Jews and that the evils of today were the product of Jewish conspiracies. This vile anti-Semitic outburst was delivered at a Boston rally attended by Birch founder, Robert Welsh. How pro-Jewish in any sense can one be, who allies himself with Birchers?)

"I teach the largest LDS youth group in Clark County, which meets every Tuesday night. I have been their instructor for two years now. Rabbi Gold through my invitation appeared and spoke to the group during March, 1966. I recently strongly urged upon my class the necessity of going to see the movie, 'The Ten Commandments,' and we discussed at some length modern significance of Moses, the Children of Israel and the events depicted in the great film story."

(Did Rabbi Gold know you were allied with Birchers when he agreed to address your class? When you discussed the modern significance of Moses with your pupils, did you tell them of your association with Birchers, who deliberately are promoting hostility between Christians and Jews?)

"2. INVOLVEMENT WITH THE JEWISH COMMUNITY. My personal involvement includes an appearance before the B'nai B'rith where I spoke on functions at the Temple, including the installation of Rabbi Gold."

(It was the Anti-Defamation League of the same B'nai B'rith that charged the John Birch Society with taking a long step towards its appeal to bigots. They are the same Birchers, Ted, with whom you are allied today.)

' In 1963 when General S.L.A. Marshall spoke at the Bonds for Israel dinner held at the Hotel Sahara, I was called upon by Judge Zenoff to introduce him. Gen. Marshall is the author of 'Sinai Victory,' the best available text on the 1956 Sinai war -- I paid personal tribute to the Israeli army -- Gen. Marshall and I became close personal friends. --"

(Ted, since you interject the name of Judge Zenoff in your background in your appeal to Jewish voters, it is only fair that I report at this time, it was the same Judge Zenoff who is a member of the Nevada Supreme Court that disbarred you from legal practice for a year for remarks against that tribunal. We don't think he would call on you for any respectable function in the future. We also do not think Gen. Marshall would continue the close personal friendship if he became aware of your attachment to the Birchers.)

"3. DA'S OFFICE EMPLOYMENT RECORD. I have had several Jewish employees at the District Attorney's office during my tenure there --. At present I have ---, a deputy.

"I have also had numerous negroes in my employ. At present two key subordinates -----, and -----, are both Negroes.

"In other respects the office is a very composite group. There are Catholics, Protestants, Mormons, etc. We are completely integrated in every religious respect and we all get along fine."

(Do the single Jew and two Negroes in your employ, Ted, know of your relationship with the Birchers? How do the Catholics, Protestants and Mormons feel about this connection? Do all of these employees know that Arnold Forster, general counsel of the Anti-Defamation League, just two months ago charged the Birchers with knowingly twisting the facts of a study that took five years by the University of California Research Center? The study was made possibly by a half million dollar grant by the ADL, and is already being used by Catholic and Protestant religious leaders who are concerned with the problem of anti-Semitism and are seeking ways to solve it. The fact that the Birch Society employs a handful of paid Negroes does not mitigate its opposition to civil rights legislation designed to correct racial inequities. Does it Ted?)

"4. PERSONAL SENTIMENTS. I believe strongly that Chief Justice Earl Warren hit the nail right on the head, when he said, at the Capitol ceremony over President Kennedy's body, that 'racial hatred and intolerance is eating its way into the blood stream of this nation.'

"I have not tolerance whatever for either racial or religious intolerance. In any public office I ever hold or any private enterprise I venture upon, such attitudes will never be permitted by me."

(Ted, you quote Earl Warren, the same man the Birchers advocate impeaching from his high seat on the U.S. Supreme Court. The President Kennedy's body, you mention, would be turning over in its grave if it knew it was being used in vain by anyone even remotely associated with Birchers. It was reliably reported to this writer that you, Ted, told a Henderson group recently, that the Nevada Supreme Court is more to the left, than the U.S. Supreme Court. If that isn't Bircher language, what is? And finally on this point, this writer distinctly remembers a younger, more respected d.a., who bravely led a group of marchers in a hike from Las Vegas to Henderson, in keeping with the late President's physical fitness program. Would the late President Kennedy, who you respected and admired so much, approve of your association with the Birchers, whose every tactic and purpose, he scorned? How do you reconcile all this, Ted?)

"5. POLITICAL VIEWS. Politically speaking, I am and have always been a Democrat. In 1963 I was elected National Committeeman of the Las Vegas Young Democrats. I served in that post two years and was honored to stand in

the receiving line for President Kennedy by virtue of it.

"In 1964 I worked actively for the election of both President Johnson and Senator Cannon. I personally supervised several of the Democratic youth activities, especially the young people's rally which was a high point of the Johnson-Cannon campaign."

(Your claim of being a true Democrat is questionable, Ted. The Democratic State Convention, in no uncertain terms, repudiated the John Birch Society and all it stands for. For that matter, to a lesser degree, so did the Republican State Convention. To this writer's knowledge, you, Ted, are the only Democratic office-seeker who publicly associated himself with the Birchers, in direct contrast to the policy of the party you claim as your own. That's not all. A group of insurgent young Republicans, who bolted their own party platform because of the anti-Bircher plank, have openly published a periodical endorsing your candidacy. This disproves the Bircher bleat that it is not political -- strictly educational. If anything, this one gesture proves beyond doubt that being a Bircher is more important to some than being a Republican. It also proves that the Birchers have no party lines. They'll go to anyone who'll have their un-American, uncouth and undesirable support.)

"During the present campaign I have publicly made the statement that I both solicit and will accept the support of any and all political minority groups, regardless of what those groups or individuals believe, PROVIDING THEY SUPPORT WHAT I BELIEVE.

"I draw no distinction against any of the minority groups that exist in the political world. I am conscious that the world is made up of minorities and it is regrettable that there are so many differing points of view, some of them diametrically opposed to the other. Nevertheless, as governor I intend to represent ALL the people and to follow the voice of my own conscience to the best of my ability. That being the case, I will accept the support of any and all citizens be they Catholics, Protestants, Jews, Mormons, Negroes, Indians, Right Wingers, Left Wingers, Birchers, Liberals, Moderates, Conservatives, or whatever they may be. The only test is whether or not they support what I as a candidate believe in. If they can square their own conscience with my platform, I welcome and solicit their support."

(Here is the substance that caused this writer to change a former friendship into an unfriendly one, with all the proportions we maintain for those whose philosophies are hostile to our heritage and faith as an American and a Jew. This is too much. How far can a man go to insult the intelligence of the voting public? Either Marshall is the most naive guy around, or he's the cutest. In any case his admission is revolting for a number of reasons. He fools no sensible persons by grouping all minorities in a common cause with his name at the rainbow's end. Only the most ignorant of those whose votes he is soliciting will be confused into misunderstanding his motives. Here is an admission of an indefinite platform. Here is a candidate who will solicit any slime or slut, from card holding Commies, who seek to overthrow the country by force, to Rockwell Nazis, whose purpose is to eliminate all Jews and Negroes. Here is a man who hopes to snare votes because he is the lesser of evils represented by the other candidates. Here is a man who hopes to back into the office, rather than be elected on the strength of his own beliefs and commitments, which are both vague and all-inclusive. The only thing positive about his platform, so far, is his indelible allegiance to those whose support he is soliciting.

Otherwise he would be double-crossing those whose representation he seeks. C'mon, Ted, who ya kiddin'?)

"6. DA ACHIEVEMENTS. Without belaboring this information, as District Attorney of Clark County during the past four years I have been an aggressive champion of strong and vigorous law enforcement in Nevada.

"Our work and policies paid off handsomely in 1965 when for the first time in many years there was a significant decrease in the crime rate of Clark. Las Vegas is no longer the No. 1 crime city of this nation. We have maintained a very high conviction rate.

"The Civil functions of the DA's office have expanded rapidly during these years and have never been handled more adequately. Numerous new ordinances have been written and reams of legal advice given out to the various county officials who must administer their own departments.

"The use of the grand jury to break the logjam of cases in Justice Court was my own personal invention. Over 200 criminal indictments were returned by our Clark County Grand Jury within an eight month period. Justice was speedily expedited thereby. In one instance the short time of only 52 days elapsed from the date of a heinous murder until the defendant was convicted and sentenced to prison.

"The number one item on my gubernatorial platform is reform at the state wide level as concerns crime and parole aspects of state government. It serves little purpose for police and prosecutors to convict criminals when the governor, the parole board and the Supreme Court are standing by to release them at the earliest possible moment."

(We make no comment on the claims in the above statement. We are concerned only with items that affect the welfare and growth of the Jewish Community in Nevada.)

"7. FAMILY MATTERS. I am married to Luana Rushton Marshall. Our marriage is now entering its 14th year. We have 5 children, Vicki, Ward, Patricia, George and Robert. The last four have all attended and graduated from the Las Vegas Jewish Community Pre-School which is taught on the grounds of Temple Beth Shalom. We feel the instruction they have received there has been most helpful and vital to their future."

She is a devoted mother and a conscientious community worker on charitable projects, especially the City of Hope. Your children are all-American. Their attendance at Las Vegas Jewish Community Pre-School, shows excellent judgement on the part of their parents in sending them to the best accredited school of its class in America. We hope your children will never be promiscuous in welcoming or soliciting support from any and all factions including those that are evil and undesirable.)
