## Meet a Real Guy

One of the first instructions to his deputies issued by Clark County George Franklin on taking office last month is to seek justice before prosecution.

Deputy District Attorney Addeliar D. Guy, whose assignments are preliminary hearings in Justice Court for those charged with a crime will extend as much effort to free a man he believes innocent as he will to prosecute one, where circumstances show guilt.

Guy, a holdover from D.A. Marshall's regeme where he served as special investigator, was admitted to the Bar of Nevada in Dec. 1966. He is the fourth Negro licensed to practice in this state. A fairly newcomer to Las Vegas, from Chicago, where he was born and raised, he not only brought with
