Birch Rally Coming Up

Leafing through the plans and musings of the Birch world early this year, I came across two items which seem worthy of comment: (1) Edwin A. Walker, the Major General who resigned his commission in 1961 to fight Communism the Birch way, will be the guest of honor at the "God & Country Rally" in Boston early in July, 1967; and (2) American Opinion, edited by Robert Welch, has offered gratuitous advice to Orthodox Jews on how to eschew the liberal route in political and economic thought.

It was at the 1966 "God & Country" Rally, a swarming Fourth of July place for Birch barkers, that Dr. Revilo P. Oliver bespattered the Jews. This University of Illinois savant, who had earlier contended that it was a lie that the Nazis killed 6,000,000 Jews, had been hailed by Mr. Welch as "an authentic genius of the first water and quite possibly the world's greatest scholar." Before all the returns were in from that poll, Dr. Oliver had told the "God & Country" assemblage that, in his judgement, a Jewish conspiracy was in part responsible for the decay of western man. Subsequently, the governing body of the Birch Society and Dr. Oliver took separate paths,

Now there comes riding over the hill toward the 1967 rally former General Walker, hailed thus: "Our country owes a debt of gratitude to General Walker for initiating his 'Pro Blue' program of troop indoctrination, General Walker had seen what heppened in Korea when young American soldiers were so confused by propaganda and lack of educational training... that they were not certain that American Liberty was siperior to Communist Slavery." He was determined, his sponsors declare, "to see that the men in his command really understood American Freedom in a Christian Constitutional Republic."

General Walker's way of going all out for these objectives was (according to Army authorities) to make "inflammatory and derogatory" statements about President Truman. Later on, when he got his day before the Special Senate Preparedness Subcommittee, he implied that President Kennedy, President Eisenhower, Denfense Secretary McNamara, and Mrs. Eleanor Roosevelt were either dupes or conscious advocates of a policy of "collusion and collaboration" with the Communists. Before he resigned hie commission, some held that he had been violating AR 355-5, which prohibits officers from publicly attacking past or present government officials.

Ladies and gentlemen, we have made a mistake which we feel should be corrected immediately by the only method we know -- a clean breast of the entire story with the hopes those offended will accept our apology and understand the honest intentions of our action.

As an inducement for subscribers to send their checks in early, we offered a free dinner at Pat's Chinese Kitchen or Pat's Bar-B-Que Kitchen. Little did we realize at the time, that there would be some, among the thousands who are receiving the paper each week, who would object to this specific free gift made by an English-Jewish publication. Four rabbis, so far, have complained, one ve-

hemently. There may be others.

In any case, the initial purpose of the Las Vegas Israelite, created to serve the welfare and growth of the Jewish community, never meant to be the moving force of annoyance to even a single person, especially a member of our own Faith and certainly where tradition, custom and basic laws are involved. This does not mean, mind you, we re-linquish the right to criticize and defend our views when we feel a transgression has taken place. But when we instigate a circumstance which proves distasteful, and we realize the error of our ways, we accept full responsibility and hasten full speed to make amends without qualification or attempt to justify our deeds. We are genuinely sorry and will be careful not to commit any similar breach in the future.

By way of explanation, we repeat NOT justification, the free dinner was chosen because we honestly believe that right now about 90 percent of the members of our Temple are regular customers of Pat's. We do not recall ever entering either of his establishments and not being greeted by at least one member of our Faith, Many of these patrons, who do not observe our dietary laws when dining out, maintain a kosher home, like this writer. It may not be in keeping with strict Jewish tradition, but these are the circumstances that exist. We doubt if anyone will refute this claim. That is why we inadvertently chose the free dinner as a gift. It was to serve those who had already broken the tradition, in addition to the many gentile sub-

However, as one complaining rabbi pointed out, to encourage the breakdown of tradition, was gross error on the part of an English-Jewish publication. After careful deliberation, once it was brought to our attention, we agree.

After all, knowing the nature of the Jewish community of Las Vegas as well as anyone, we would venture to guess that the vast majority sprung from Orthodox homes. To determine when and where they first strayed from our kosher tradition would mean exploration into each individual's background. If they were strict adherents when they first came to Nevada, there may be reason, and possible justification why they relaxed. There is not a single kosher restaurant in the entire state. We do have a kosher butcher, Sam Klein, a decent, religious member of our Faith, who serves his customers well. But the only place we know, apart from homes, where strict kosher observance is maintained, is our Temple Beth Sholom, and only within the past two years.

A word about Pat Ginn, who of course, cannot be blamed for the indiscretion of this writer. Pat has earned the reputation of supporting all good causes, especially those attached to the Jewish Faith. He believes without qualification, the success of his two establishments is due mainly to patronage of members of the Jewish community. On occasion we jokingly refered to his Chinese kitchen as an annex to our Temple. He often calls himself Pat Ginnsberg. He is a fine, decent, upright citizen, who made his own way in life since arriving in America at the age of 11. He never forgot the kindness of a San Francisco Jewish family, where he first served as houseboy, but later just as one of the sons was sent through college. So much for Pat.

Now about the offer of free dinner, which we must of necessity rescind. After bringing the complaints to the attention of Pat, it was decided to repeat the offer of last year, which proved ever so popular and about which there was not a single complaint -- a box of 100 authentic, Chinese tea bags (retail value \$2,25). One small complication. The tea is being ordered immediately by Pat, but there will be a delay of approximately one-month before delivery from Hong Kong. So please be patient, folks. This, of course, will include out-of-town subscribers, who could not participate in the previous offer.

There you have it, and we ask for your understanding. What more can we say?
