The group will visit Tel Aviv, Jerusalem, Beersheba, Tiberias, Eingedi, Haifa, Eilat and Caesarea.

Heavy emphasis will be placed on visiting the territories added to Israel as a result of this past summer's conflict. The group will visit the old city of Jerusalem which, for decades has been closed to Jews, and see the ancient shrines of Christian and Moslem, as well as the Jewish, religion, such as the Citadel of David, the Church of the Holy Sepulchre, the Gate of Damos, the Tomb of Mary, Mt. of Olives, the Dome of the Tock, the MOSQUE EL-Aksa and the Walling Wall.

Another highlight of the tour will be a flight between Tel Aviv and Eilat, over the Sinai battlefields to Mitla Pass, littered with remnants of the recent war. The plane will then turn south along the shores of the Red Sea and will fly over Charm el Sheikh, the Straits of Tiran and back up along the Gulf of Eilat Eilat.

The group will be in Jerusalem on May 2 where the 20th anniversary of Israel's independence will be celebrated. Arrangements are being made for tickets to the parade and other related festivities.

ISRAEL SEES ONLY DIRECT NEGOTIATIONS

JERUSALEM (WNS) The Israeli Cabinet issued a statement in which Israel sees only one way for the solution of the problems of the Middle East -- through direct negotiations with her neighbors, leading toward the conclusion of peace treaties.

"The Cabinet confirms the statement made by the Foreign Minister to the effect that Israel will not cooperate with the U.N.'s special representative, if he is given instructions contrary to Israel's principles of freedom of action in any forthcoming negotiations," the statement declared. Foreign Minister Abba Eban had warned in New York that Israel would not cooperate with any U.N. representative whose frame of reference would be

based on the draft resolution now before the U.N. Security Council as introduced by India, Mali and Nigeria.

(At the U.N. Security Council meeting in New York, Mr. Eban was to be the first speaker on the Council's list at the beginning of the week.
