JEWISH NEWS BRIEFS

TEL AVIV (WNS) Two Arab saboteurs were killed when they attempted to blow up a bridge on a road to Eilath.

JERUSALEM (WNS) Twenty terrorist suspects, believed to be members of the El Fatah gang, were reported arrested in a surprise raid in a large village in the Jenin area. All men in the village of 6,000 were questioned for identification at the town square.

TEL AVIV (WNS) Israeli and Egyptian forces engaged in an artillery duel in the southern tip of the Suez Canal, The fighting started as a result of an incident triggered by the Egyptians. When the Egyptians used artillery and mortars, the Israeli forces replied in kind.

WASHINGTON (WNS) The possiblity of a link between the bombing late in May of a synagogue in Meridian, Miss., and the anti-Semitic National States Right Party is being investigated by the FBI. No arrests have yet been made.

NEW YORK (WNS) The Council of Jewish Federations and Welfare Funds has announced completion of the first phase of a study of the Jewish population in the United States, the pooling of all known information on the Jewish population for every county in the country.

NEW YORK (WNS) Disclosure of a "genuine idealistic trend" among important groups of American students toward participating in the Israel Peace Corps was made here by Dr. Aryeh Nesher, coordinator of the program, known in Israel as Sherut La'am.

LONDON (WNS) The Times of London carried a letter from a man in Moscow claiming that many Soviet Jews who left or Israel in 1966 and 1967 were now anxious to return to the Soviet Union.

PARIS (WNS) Foreign Minister Michel Debre, replying to a question why the de Gaulle regime is refusing to deliver to Israel the eighty Mirage jet fighters it ordered and paid for, said the balance of power in the Middle East must not be disturbed.

NEW YORK (WNS) Of the more than 20,000 Jews who fled from North Africa since last June, more than 16,000 have found haven in France, it was disclosed here by Samuel L. Haber, executive vice-chairman of the Joint Distribution Committee.

JERUSALEM (WNS) Unearthing of stones that ere used to pave the path to the Southern entrance of the Temple in Old Jerusalem was disclosed here by an archaeological team under the aegts of Professor Benjamin Mazer of the Hebrew University.

JERUSALEM (WNS) Sephardic Chief Rabbi Yitzhak Nissim of Israel will visit Rumania this month as guest in Bucharest of Rumanian Chief Rabbi Moses Rosen, it was announced here by his office.

FRANKFURT (WNS) Two of Adolph Eichmann's top aides, otto Hunsche and Herman Krumey, were placed on trial here for the second time on charge of complicity in the slaying of hundreds of thousands of Hungarian Jews during World War II. Both men were tried on the same charges in 1965, but one of them, Krumey, was acquitted for lack of evidence. Hunsche was convicted and given a five-year term. On appeal, both the acquittal and the sentence were upset and the men were ordered to stand trial again.

JERUSALEM (WNS) Minister for Religious Affairs Dr. Zorah Warhaftig, in a speech on the floor of Knesset, called on Moslem religious leaders to halt political resistance to Israeli authorities in Jerusalem and the occupied areas. Dr. Warhaftig made the plea as he reported on the damage of Jewish holdy places in East Jerusalem during the nineteen years of occupation by Jordan, He estimated the restoration cost of the cemetery on Mt. Olives alone at more than \$1.7 million.

BUENOS AIRES (WNS) Disclosure that DAIA central Jewish representative body in Agentina, had asked for a meeting with Minister of the Interior Dr. Guillermo Bordia on Nazi activities in the country, including the dissemination of hate literature against Jews, was made here by Dr. Isaac Goldenberg, president of the organiza-

JERUSALEM (WNS) Two Israeli soldiers were wounded in a clash with Jordanian armed forces in the Beisan valley, it was reported here by army officials who said the attackers used machine guns and other weapons.

WASHINGTON (WNS) The State Department has no evidence that Sirhan Bashira Sirhan accused killer of the late Robert F. Kennedy, had returned to the Middle East after coming to the U.S. in January of 1957.

JEWS SUFFER IN ARAB LANDS

UNITED NATIONS, N.Y. more than 1,000 in Aleppo (WNS) The situation of Jews in Syria, Iraq, Egypt and in a number of other countries was described here as extremely grave by Yosef Tekoah, Israel's Ambassador to the United Nations, in talks with Secretary-General U Thant.

The meeting was held against the background of a planned special UN mission to study the plight of civilians in the aftermath of last year's war. Israel has made it known it would cooperate with the mission, but it asked that a study be also conducted of the Jewish situation in the Arab countries. So far, the Arab states indicated resistance to the proposal.

According to available information, some 250 Egyptian Jews, all heads of families, are still languishing Jews is even worse. They in the prisons into which they were thrown when war broke out with Israel last year, even though no charges have been filed against them. Egypt now has a total Jewish community of 2,500, about evenly divided between Cairo and Alexandria.

Syria has a Jewish population of about 3,500, some 2,000 living in Damascus.

In Damascus a number of Jews have been arrested and the Jewish pedestrians are exposed to attacks, stoning and threats, A Syrian Army circular recently carried a listing of Jewish shops from which army personnel were warned to keep away.
