

JEWISH NEWS BRIEFS

JERUSALEM (WNS) Denial that he ever raised the territorial issue with special UN envoy Gunnar V. Jarring was made here on the floor of Knesset by Foreign Minister Abba Eban amidst growing indications of widening areas of opinion in the country about the ultimate settlement of that problem.

LONDON (WNS) Wolf Mankowitz, noted Anglo-Jewish writer and dramatist, has been awarded the 1967 Martin Buber Prize for Literature, but he allegedly turned it down because of disagreement with some of the fundamental concepts of the late Jewish philosopher and mystic.

TEL AVIV (WNS) Eight Arabs accused of gathering and passing on information to Egypt about Israeli troop and coast guard movements will go on trial before a military court in Gaza.

RI ODE JANIERO (WNS) A ritual slaughterer in the provincial capital of Curitiba, where Hitler's top aides are hiding, was shot and seriously wounded by an Arab assailant said to have been motivated by hatred of Jews, Israel and Zionism.

NEW YORK (WNS) Acquisition of the personal files of Bernard G. Richards, founder of the Jewish Information Bureau, was announced here by the Jewish Theological Seminary of America.

JERUSALEM (WNS) Belief that Israel's security must be the primary consideration in any peace negotiations with the Arab states and in the determination of future boundaries was voiced here by Minister of Defense Moshe Dayan in a speech of security matters at a closed meeting with the Labor faction in Knesset.

NEW YORK -- Torah convocations for Jewish military personnel on duty with the U. S. Air Force in the Far East - Hawaii, Guam, the Philippines, Taiwan, Okinawa and Japan - will be conducted from July 11th to August 4th by Rabbi S. Gershon Levi, vice-president of the Rabbinical Assembly, it was announced by Rabbi Selwyn D. Ruslander, chairman of the National Jewish Welfare Board Commission on Jewish Chaplaincy.

ISRAELITE ENDORSES CANTER

Temple Men's Club president David Canter is a candidate for Clark County School Board Trustee, District No. 2, running in the unincorporated areas of Las Vegas, North Las Vegas and Goodsprings Townships.

Canter, long interested in school matters indicated his intention "to make sure that every dollar of School District money will be spent wisely and well in the best interests of all our children."

In his statement, Canter declared that "a decent respect for the teaching profession" requires a fair and just administration of the provisions of the recent Teacher Tenure Law not only to attract the most capable teachers to Southern Nevada, but also to stabilize teacher employment and improve their moral and
