ORDER DESIGNATING LAS VEGAS ISRAELITE AS A WEEKLY NEWSPAPER OF
GENERAL CIRCULATION ENTITLED TO PUBLISH LEGAL NOTICES AND AD-
VERTISEMENTS, PURSUANT TO NEVADA REVISED STATUTES 238.030.

newspaper of general circulation published for the dissemination of legal news and gen-
eral news at Las Vegas, Nevada; that LAS VEGAS ISRAELITE has a bona fide sub-
scription list of paying subscribers; that LAS VEGAS ISRAELITE has been duly
entered, as second class mail matter by the United States Post Office, Las Vegas,
Nevada, on February 26, 1965, and such permit is now in full force and effect, now
therefore, it is hereby
ORDERED, ADJUDGED AND DECREED that the prayer of Petitioner be granted,
and that LAS VEGAS ISRAELITE is hereby determined and declared to be a legal
newspaper and is entitled to all privileges appurtenant to such status.
