JEWISH NEWS BRIEFS

NEW YORK (LNS) - Nearly one hundred Rabbinical students of the Lubavitcher Yeshiva in New York will leave to tour hundreds of Jewish communities throughout the United States, Canada, Mexico and Latin America. They will meet with Rabbis and Jewish communal leaders. visit synagogues and Jewish educational institutions, and meet thousands of Jew comprising the grass roots Jewish populace in homes and on the streets.

NEW YORK, N.Y. -- An Israeli - American Youth exchange program began when 20 Israeli teenagers and three adult leaders arrived for a four-week tour of U. S. and Canadian Jewish communities and to participate in activities at the B'nai B'rith Youth Organization camp at Starlight, Pa.

TEL AVIV (WNS) The death of two high ranking Israeli officers in a clash with El Fatah saboteurs was mourned throughout the country amid growing determination to strengthen Israel's security against marauders.

N.Y. (WNS) A call on the government of the United States to supply Israel with Phantom jets so that it may maintain the military balance in the Middle East, was sounded here by Jacques Torczyner, president of the Zionist Organization of America.

JERUSALEM (WNS) Israel this year expects the arrival of 35,000 new immigrants, some 15,000 of them from the more affluent countries, according to a spokesman for the aliyah department of the Jewish Agency.

BONN (WNS) Former SS officer Rudolph Zimmer was sentenced to life in East Berlin on charges of involvement in the mass murder of Polish Jews in 1943,

LONDON (WNS) Information reaching here from Warsaw indicates that the anti-Jewish drive in Poland has not abated. The latest victims there to lose their government positions are four Jews and a Christian woman married to a Jew Several of the ousted Jews were members of Poland's delegation to the disarmament conference.

SANTIAGO DE CHILE (WNS) For the second time in a week, a Jewish organization, Institute Hebreo, has been the target of molotov cocktail throwers. There were no injuries and the damage by fire was slight.

WASHINGTON (WNS) Reports reaching here indicate a deep split in the Algerian Cabinet over the issue of releasing or detaining the hijacked Israeli plane, its crew and male Israeli passengers.

TEL AVIV (WNS) Israel needs doctors and clincians to serve in remote settlements and townships and is therefore currently directing its efforts toward getting such recruits from England, France and Latin America.

Jerusalem (WNS) Arthur J. Goldberg, former U. S. Ambassador to the United Nations, has been named chairman of the board of trustees of the Harry S. Truman Center for the Advancement of Peace. Prior to leaving Israel after a five-day stay, Ambassador Goldberg said Israel had a right to insist on "durable and lasting" peace terms and 'not to be satisfied with temporary arrangements."

SYDNEY (AUSTRALIA) (LNS) - Rabbi Pinchus Feldman, 24, a native of New York and a third generation American, has been appointed as spiritual leader of one of the largest Congregations here in Sydney, and as Dean of the Sydney Talmudical Academy.

LOS ANGELES: - Lionel Dyck, National Deputy Hospital Officer of the Jewish War Veterans of the United States, and his co-worker, Emanuel Seidman, have been awarded the Aaron Chernoff Award of the Jewish War Veterans for thier devoted service to the hospitalized veterans over the past year.

NEW YORK: A specially designed soundproof observation room has been installed in the Massada School in Tel Aviv, the only school of its kind in Israel for brain-injured children.

HEMPSTEAD, N.Y. (WNS) Dr. Samuel M. Blumenfield, noted Hebrew scholar and author, has been named Visiting Professor of Hebrew Liberature and Culture by Hofstra University here for the academic year 1968-1969.

The Arab population in Israel has come to realize that the word "Israel" is no longer to be used to exploit hatred, but that it is in reality the name of the country in which they can live in peace and harmony, The terrorists are not local

This development, the Minister added, Foreign "strengthens Israel's duty and resolves to maintain the conditions necessary for its security until such time as UAR policy undergoes a complete transformation." Apart from its significance in the Arab-Israel world, Mr. Eban noted, "the speech is notable for its complete subordination to the policies of a foreign great power and for its efforts to stir up new tensions in the relations be-

tween the great powers,"
