

**J.P. Up For Re-election**



Justice of the Peace, Joe Pavlikowski, filed for re-election as Judge of the Justice Court of Las Vegas Township.

Pavlikowski formerly served four years as a Deputy City Attorney for Las Vegas. In that post he prosecuted in excess of 10,000 cases in the Municipal Court.

He was elected Justice of the Peace in 1966 and was one of the first magistrates to hold office after the dual Justice of the Peace posts were created by state legislature. This was done in an attempt to cope with the expanding work load of the Justice Court.

Pavlikowski said he decided to seek re-election because "I want to finish the job I started." Pavlikowski has initiated procedures that have greatly expedited the elimination of the backlog in both criminal and civil cases in Justice Court. Upon taking office, the court calendar was back logged in excess of nine months in criminal cases. That condition has now been cut to approximately two months. This is a record in recent Justice Court history.

"I am striving for a separation of the Justice Court into independent departments. I am in favor of a system resembling that presently followed in District Court. I feel that this would be a more efficient means of handling the business of Justice Court. I also feel that this system will enable future magistrates to keep abreast of the population growth."

Pavlikowski said that he feels that Justice Court is a complicated and important office and that the experience he has gained in the last year and a half will help him to continue up grading the services of the Court and to do the best possible job.

A sixteen-year resident of Nevada, Pavlikowski was educated at Notre Dame and St. Bonaventure Universities and received his law degree from Washington College of Law. He was an Air Force jet pilot during the Korean War and flew over 100 combat missions.

He is a member of the Rhode Island Bar Association, the Nevada Bar Association, the Clark County Bar Association, and the American Bar Assoc.

Sam has been a practicing attorney since 1952. In 1953 he was elected to the City Council of Central Falls, Rhode Island, and was elected for three consecutive 2-year terms, during which he served as President and President Pro Tem of the Council, and as a member of the Council was appointed Chairman of the Liquor Board.

"The greatest service our Justice Court can perform for the people of this community is to hold more evening sessions on small claims and traffic charges. Too many of us are forced to give up a valid claim or defense because we cannot take the time off from work during the day to protect our rights."
