LONDON (WNS) The alleged would-be-assassin of Premier George Papadopoulos of Greece is a deportee from Israel, where he lived for a time last year. The accused man, George Panagouliss, deserted from his Greek army unit in August of last year. He was later arrested in Israel for extradition to Greece.

TEL AVIV (WNS) The Ministry of Agriculture announced that twelve Sardinian farmers were visiting Israel as its guests to study Israeli methods of cultivating citrus fruits and vegetables. The visit was arranged with the cooperation of the Italian Ministry of Agriculture.

GENEVA (WNS) An appeal to Jews and Jewish organizations to rally to the aid of the international bodies in their efforts to provide relief for the stricken people of wartorn Biafra was sounded here by Dr. Nahum Goldmann, president of the World Jewish Congress.

JERUSALEM (WNS) President Johnson sent a message to Premier Eshkol hoping that the joint American-Israeli effort to establish a water desalination plant in this country will materialize before he leaves office next January.

NEWARK (WNS) A man who contended that he could better raise his two children as Jews than his divorced wife who lives in a non-Jewish climate has been upheld by the Essex County Superior Court in a ruling which gave him custody of the two children.

JERUSALEM (WNS) Expulsion of three Orthodox Jews from Hebron because of their refusal to tear down a kosher food stand they built in violation of local ordinances was upheld in Knesset by Premier Levi Eshkol, who told parliament the action was taken by the military governor after he and Minister of Defense Moshe Dayan approved the order, Hebron is in the West Bank.

BELGRADE (WNS) The Jewish almanac published here by the Federation of Jewish Communities of Yugoslavia carries a short story by S. Y. Agnon and a poem by Nelly Sachs, co-winners last year of the Nobel Prize in Literature.

TEL AVIV (WNS) Bazooka and machine gun fire in the Beisan Valley injured two Israeli border policemen, it was reported by army spokesmen who said this was the second incident within a period of hours. The first clash occurred some 300 yards from the Jordanian border.

JERUSALEM (WNS) Five Arabs in East Jerusalem who abandoned their homes twenty years ago had their properties returned to them and three more applications for restitution of property are still pending,

JERUSALEM (WNS) A planned trip to Algeria by UN Secretary General U Thant has been canceled because of that country's continued refusal to release the hijacked Israeli plane, its crew and passengers, according to information reaching here from the United Nations in New York.
