Piracy

Algeria's refusal to release the hijacked Israeli plane, its crew and passengers is another illustration how international diplomacy flounders when matters affecting Israel are involved.

It is four weeks now since the plane was hijacked as it left Italy -- in fact it may have been over Italian territory when the goons took over and still there are no indications on the part of Algerian authorities that they are ready to make a move. When the plane was first forced to land on an Algerian airport, it was widely believed no responsible government would risk being branded an accomplice to the crime of piracy, but it now seems that those elements in the Middle East who have been defying world public opinion with impunity over the years, and often with the silent blessing of the Arab and pro-Arab bloc in the United Nations, are again hoping to be exonerated by their friends in the counsils of the nations.

Israel is properly taking a serious view of the situation, for what it amounts to is world countenancing of Arab blocking of its air traffic with impunity, Civilized nations don't behave that way. Even Cuba, with its deep well of hostility toward the United States, has never failed to return a hijacked American plane.

History has a peculiar sense of retribution of its own. The downed Syrian planes on Israel territory in what was described as navigational mistake is a case in point, even though the two incidents have no common elements.


It seems to us that if the UN cannot or will not act our own government together with other aerial nations should step into the picture. If air piracy is condoned, none of us is safe in flight.

Dear Mr. Tell:

Your editorial of Friday, August 9, about Bill Raggio has greatly dismayed and shocked many people including prominent leaders of the Reno Jewish Community.

As the only Rabbi in Reno over a 400-mile radius, and with no ulterior motive other than satisfying a deep sense of fairness and ethics, I feel compelled to appraise you of the following facts:

I have only been in Reno since September of 1966, when I took my first pulpit. I am called upon, not only to minister to the Jewish community but also to be their spokesman to the Gentile community. Since, more often than not, Religion and Law go hand in hand, Bill Raggio and I belong to mutual organizations, serve on the same panels and participate in open discussions on subjects of vital importance to the entire community. It is inevitable, then, that through him, I get to know him quite well, and I find it simply incredible that he could be labeled as an anti-semite.

Long before any thought of running for political office, he has been consistently willing to help the Jewish cause, either actively or by lending his name when he was not available. He is a long-time active Executive Board member of the National Conf. of Christians and Jews, and has done an excellent job as the Chairman Dr. Heinz Rittig of the Christian Campaign Mr. Hank Greenspun (67-68) for U.J.A., as can be attested to by our very good friend Dr. Berger, Chairman of the No. Nevada U.J.A. He and Mrs. Raggio your paper.

dox Rabbis all over the country, accusing us of encouraging Jews to eat non-Kosher food. It seemed incredible, we'd found ourself in that predicament, but we realized we did offend some devout members of our Faith. We publicly admitted our mistake, withdrew the offer, said we were sorry, and promised to be more careful in the future. Let's look at the other hand.

If we are correct in our original premise, we stand by our guns. Naturally we expect some irate target of our statements to expostulate in his own defence. We print his retort without comment. It is the policy of the Israelite. We've had our say, he's entitled to his.

So far, the denunciations touched on everything from our legitimacy to our sanity, but invariably little or no mention was made of the important issue we had made public. Here is an example of the past to prove our point,

It took place about two years ago, when we charged a candidate for the nomination for governor with seeking the support of the John Birch Society. We pointed out how certain leaders of the society, at the time, were notorious anti-Semites. The retort came, of course, which we ran in its entirety. It was worded in the usual vein, calling us all the epethets barely printable in a family newspaper. Long and loud was the bleat that he never had been, nor was he then, a member of the John Birch Society (which we never charged him as being.) But he did reiterate that he welcomed the support of anyone who preferred to vote for him, be they Jews, Catholics, Mormons, Negroes, Communists, or Birchers -- which was exactly the issue, and the sole one, we had brought forth.

Now we find ourself in a situation where a Republican candidate for nomination for U.S. Senator saw fit to oppose President Johnson's nomination of Supreme Court Justice Abe Fortas to Chief Justice, Fortas is the first Jew ever honored with that distinction. Naturally, we are proud to have member of our Faith rise to that high position.

It is not unusual for elected members of the opposition party to seek to block this type of appointment, especially when the timing is proximate to an election and any furor created may cause embarrassment. Also, right now, when liberalism and conservatism has divided the country as never before, there are many honest and legitimate and decent reasons to reject Fortas, an extreme liberal. Also, there is the far-fetched but acceptable objection that Johnson, a lame duck President, should not be allowed to make so important an appointment with a few months remaining in his term of office. Lastly there is the objection of "cronyism."

This writer disagrees with all the objections, but does not disagree with the right of anyone to oppose appoint-

Then the ugly factor of anti-Semitism seeped into the proceedings, a Senate hearing to determine the qualifications of the Presidential nomination, Prof. Fred Rodell of the Yale Law School, stated: "there is no doubt about it," about the question of anti-Semitism being involved. A couple of Fortas colleagues on the Court," he said, "told me they haven't the slightest doubt that one of the objections is the fact that Abe is Jewish. It may not be the whole thing, but it is definitely there."
