JEWISH NEWS BRIEFS

WASHINGTON -- The kaddish was recited and the shofar was sounded hard by Iraq's shuttered embassy building in a memorial service for the 14 Iraquis executed by the Baghdad regime.

NEW YORK, N.Y., -- The Mizrachi Women's Organization of America will construct a major comprehensive high school for girls in cooperation with the municipality of Tel Aviv, Israel, it was announced here tonight by Mrs. Aaron Leifer, of Brooklyn, N.Y., national president.

NEW YORK -- The American Jewish Congress voiced "horror and grief" at the public hanging of 15 alleged spies in Iraq -- nine of them Jews -- and called on the State Department to use "every available diplomatic means" to prevent the execution of 65 more persons still to be tired in Baghdad.

NEW YORK; -- A stirring appeal to worldJewish leaders to react to the "international deceit practiced against the Jewish people" by resolving to "never again ape the social philosophies of these same nations", was made by Rabbi Moshe Sherer, executive president of the Agudath Israel of America.

NEW YORK -- The American Jewish Congress, the largest factor in the Jewish group-travel field, announced it was cancelling all trips to France and all flights on

NEW YORK: -- A exhibit of sixty Israeli photograph's by Miss Gertrude Samuels, for over twenty years a feature writer and photographer on the staff of the Sunday section of the New York Times, is on view at the Herzl Institute Gallery of the Jewish Agency for Israel, 515 Park Avenue,

NEW YORK: -- 28 young American and Canadian volunteers left for a six-month Sherut La'am Program in Israel where they will work in the Kibbutzim Yiron and Tirat Zvi. The group comprising high school graduates and college students aged 18-22 departed for Israel via El Al flight on Jan. 28.

JERUSALEM (WNS) -- Israel has ordered \$10,000 worth of fireworks from France for use at Independence Day celebrations next May.

NEW YORK (WNS) -- The Jewish National Fund will send its first study mission to Israel, composed of JNF leaders from all parts of the United Sates.

JERUSALEM (WNS) -- The Interior Ministry has issued 2,000 new permits for former West Bank residents who wish to return from Jordan.

HEBRON (WNS) -- The first child born to a group of Orthodox Jews who settled in the formerly exclusive West Bank Arab town of Hebron has been circumcised with Menachem Beigin, Minister - Without-Portfolio, acting as "sandek."

NEW YORK (WNS) -- A study by the American Jewish Committee shows that pro-Arab sympathies in Eastern European countries remains at a low level a year after the Six-Day War, despite a vigorous campaign by Communist regimes to induce their people to support the Arabs.


