She couldn't afford an abortion and didn't know where to go for one even if she could pay.

Abortion Laws Facing Reform

NEW YORK — (NEA) — New York Protestant and Jewish clergymen formed a consultation service last year to offer help to women who faced problem pregnancies. In the first five months of its existence, it provided more than 800 women with the best medical advice with a minimum of risk to their lives and health.

THE REV. Howard R. Moody, pastor of Judson Memorial Church in Greenwich Village, one of the 31 trying to help, said: "About 90 per cent of these women chose to have an abortion."

This growing concern, indicative of the changing times, is reflected as well in both the proposed and already enacted reforms in abortion laws across the country.

It was as short a time ago as 1962 when Mrs. Robert Finkbine, a Phoenix mother of four, went to Sweden for a therapeutic abortion rather than give birth to a deformed child.

Michigan Urges Abortion Reform

A resolution urging the state legislature to alter the abortion laws so that the criminal code would not apply to abortions performed by licensed medical and osteopathic physicians in accredited hospitals was approved by the House of Delegates of the Michigan State Medical Society.

ANA Endorses Abortion Reform

The House of Delegates of the American Nurses' Assn. put the 200,000-member organization among a growing list of professional medical organizations favoring changes in "inadequate" abortion laws.
