

JEWISH NEWS BRIEFS

NEW YORK - Affluent, suburban Jews who have taken on the coloration of the gentile communities in which they live are "victims" of an acculturation process that is robbing them of their Jewish identity, according to Marshall Sklare, professor of sociology at Yeshiva University.

CLEVELAND - The National Commander of the Jewish War Veterans urged the United States to withdraw from the Four Power talks on the Middle East to avoid creating a situation far worse than exists.

NEW YORK - The American Jewish Committee, at its 63rd Annual Meeting, presented the first annual Joseph Ross Award for "Creative Achievement in Urban Affairs" to its Pittsburgh Chapter for the development of an innovative approach to meeting the need for housing for low income families there.

WASHINGTON, D.C. - A national effort to arm teenagers with the latest information about drug abuse soon will be undertaken by the 50,000-member B'nai B'rith Youth Organization.

NEW YORK - After fifty years of maintaining its offices at The Jewish Theological Seminary of America, National Women's League of the United Synagogue of America has moved its headquarters to midtown New York, having purchased and refurbished the building at 48 East 74 Street.

NEW YORK - A workshop for Hebrew teaching using the "HABET USHMA" audio-visual technique which will prepare 15 teachers for work in the Zionist youth camps this summer opened in New York under the auspices of the American Zionist Youth Foundation at 515 Park Avenue.

NEW YORK - Unless American Jews can rededicate themselves to their faith in a way that is "relevant, meaningful, and pertinent" to today's problems of morality and human relations, Judaism stands in danger of turning into "a fossil, a museum piece, a curious antique," is the warning of a young Long Island rabbi, Gilbert S. Rosenthal, in his book, "Generations in Crisis: Judaism's Answers to the Dilemmas of Modern Man," which will be published on June 9th by Bloch Publishing Company, of New York, at \$5.95.

UNITED NATIONS (WNS) -- United Nations Secretary General U Thant said he did not plan to withdraw cease-fire observers from the Suez Canal even though the situation in the area continues to deteriorate.

NABLUS (WNS) -- A Nablus mosque has been returned to Moslem religious use by order of the Ministry for Religious Affairs.

NEW DELHI (WNS) -- A number of Indian members of parliament criticized India's support of Arab states against Israel as a contradiction of the nation's professed policy of non-alignment.

NEW YORK (WNS) -- Robert Giegengack, head coach of Yale University and Irving Kintisch, assistant coach at Manhattan College have been named co-coaches of the United States Maccabiah track team.

Chicago (WNS) -- The American Jewish Historical Society has set up a \$2,500 fund to award research grants to doctoral degree candidates for projects in American Jewish historical studies.

NEW YORK (WNS) -- Yeshiva University has set up the first Doctor of Education program for Jewish school administrators and will accept the first students for the Fall '69 term.

JERUSALEM (WNS) -- Israelis who have settled in the new areas will be allowed to vote in the September general election.

between Israel and each of her neighbor states and must include "agreement on secure and recognized boundaries and the annulment of claims of belligerency, blockades, boycotts, interference with free navigation." The final point, she declared firmly, was the end of terrorist attacks against Israel and the elimination of bases and training camps for such groups.

In her talk, she warned Egypt and Jordan of the consequences of continued Arab guerrilla raids across the cease-fire lines and said Jerusalem would continue to strengthen its position along the Suez Canal because this military line was the nation's "best guarantee" during the present situation.

A few days after Mrs. Meir spoke Israel's commandos crossed into Jordan for the first time this year and destroyed a number of houses belonging to Arab terrorists.

The state of warfare along the Suez Canal and the Jordan River continues to be hot with almost daily exchanges of artillery, machine-gun and mortar fire. Israel continues its policy of using aircraft to attack terrorist bases in Jordan and has also stepped up its de-

fenses against cross-canal raids by Egyptian commandos.

Military leaders have let it be known that if the Egyptian commando raids continue Israel is ready to carry out the economic destruction of Egypt. Israel has drawn up a detailed analysis of Egypt's economic structure -- observers believe as detailed as any the Egyptians may have of their nation -- and plans have been prepared for specific attacks using hit-and-run raids and other methods to destroy economic targets. The exchange of artillery fire along the canal a few months ago completely wrecked Egypt's two oil refineries worth \$150 million and Cairo has been forced to turn to other sources for refined oil.

The big question is how long Israel will allow the Egyptian raids to continue. So far about a dozen Israelis have been killed as a result of these raids.

In her Knesset address, Mrs. Meir rejected as unacceptable proposals advanced by a number of nations because they did not include the need for a full and genuine peace treaty. She warned that "in our struggle for peace we shall face our most severe political tests but we shall not give our consent to illusory and ephemeral solutions."
