

ARSON TRIAL TO BE TELEVISED

JERUSALEM (WNS) --- Michael Denis William Rohen, the Australian member of a fundamentalist Protestant sect charged with setting the Al Aksa mosque fire, has agreed to allow his trial to be televised.

The move will enable Israel to use the trial in an attempt to offset Arab propaganda on the fire. A 300-seat hall in Jerusalem's con-

vention center is being turned into a courtroom so that hundreds of newsmen can cover the trial expected to begin later this month.

Mr. Rohen has so far refused to accept a Jerusalem district court appointed attorney, Isaac Turnik, a prominent Israeli criminal lawyer, as his defense counselor. The court has extended Mr. Rohen's deten-

tion until the end of the trial. Meanwhile at the United Nations, Arab and non-Arab Moslem nations continue to be divided on the form of a draft resolution to be presented to the Security Council over the fire. The Arab nations want an explicit denunciation of Israel and an order that it return East Jerusalem to Jordanian control. The non-Arab moslem countries, some of which have diplomatic relations with Jerusalem, are not willing to specifically accuse Israel of direct responsibility for the fire.

But in Washington 13 Moslem nations presented a demand to the United States Government that it pressure Israel to leave East Jerusalem. The nations told the U.S. they were "shocked" by the "incredible act of arson" and that the Israeli occupation was responsible.

The U. S. representative noted Washington's concern over the fire and said the State Department would "weigh carefully" the views expressed by the Moslem nations, some of which are very friendly to the U.S.

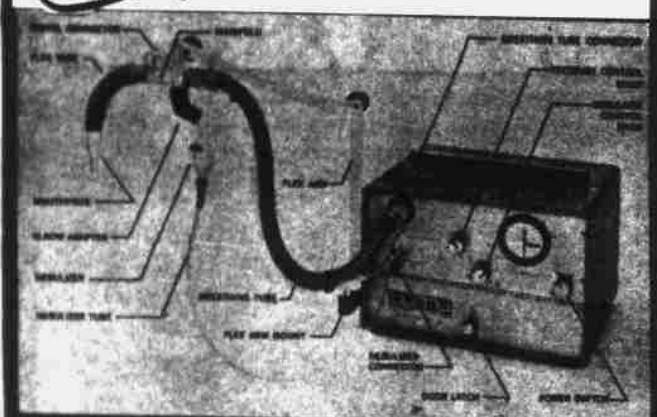
