### Communications

This past week, New York was hit by a strike of letter-carriers. At first, it was limited to two boroughs and then solidarity set in and pretty soon, the whole metropolitan area was struck or closed out by moves of sympathy. The Post Office itself declared an embargo country-wide on all mail addressed to New York.

Whether or not the strike ends soon, or the Government succeeds in obtaining a junction, it will not bast obliterate the sense of isolation which descended on the city. Communication via mail was suddenly cut off, It is only then one feels the need for it, the need to be in touch with others, the need to know what is going on in areas, be they personal and commercial, outiside the reach and cold competence of newspapers, radio and TV and the phone (if it is working). The New York area handles millions of pieces of mail daily and it is no comvort to hear Congressman Ford, a Republican leader, say he understands the motivations of the postal workers but wondered why they couldn't wait until the new Post Office scheme of President Nixon goes into effect. This is hardly balm for a working man fighting inflation for reasons beyond his own making.

But the experience underlined the need to keep in tough with people if the lesson could be widened, one could say how much more possible a happier world might be if the flow of communications were constant and free and carried the truth at all times. But somehow, unlike the blackout disaster of 1965, this mail strike has not brought the people any closer.

### Brooke us Carswell

Judge G. Harrold Carswell and Senator Edward W. Brooke have a span of life in common (both are 50 years old), but differ mightily. Judge Carswell, a white Floridian, born in Georgia, may win a niche in American history by awaking one morning to find himself a Supreme Court Justice, thanks to the fates that made him available at this point in time. Senator Brooke, a black American who has had to fight social and economic discrimination all the way, is a United States senator not because of President smiled on him but because the electorate of his state concluded he would serve Massachusetts and his nation well in a sensitive office.

To put it charitably, Judge Carswell---as a man tapped for the top bench---has made his share, and more than his share, of mistakes. When he campaigned for the Georgia Legislature in 1948, he gave written assurance he was, and would continue to be, a champion of white supremacy. In 1953, according to his own former law partner, he personally prepared the "whites only" charter of the Florida State University football boosters' club. As recently as 1966---long after the Supreme Court declared restrictive covenants could not be honored--he sold resort area land rimmed about with a clause declaring that "ownership, occupancy, and use shall be restricted to members of the Caucasion race." Lawyers and law school professors have testified

that he has, as a federal judge, in this era of revolt in the South, been brusque if not hostile to civil rights attorneys.

He has his champions, of course. President Nixon, determined to give the highest court position to a Southerner, has declared he would have elevated Judge Carswell even had he known about the jurists' 1948 white supermacy speech. In Mr. Nixon's view there is no taint of racism in the judge's make-up; his record for 18 years as U.S. attorney and federal judge is "impeccable." Georgia Senator Richard G. Russell tried hard but couldn't think of a more appropriate choice for the Supreme Court than Judge Carswell. The jurist's old law associate, Leroy Collins, a former governor of Florida, gives us his word that the judge is no segregationist, no racist. Along the way of the battle over the nomination, Senator Hugh Scott of Pennsylvania, who had the courage to buck an earlier Nixon choice, Judge Clement A. Haynsworth, appeared delighted to conclude that opposition to Judge Carswell was fading.

But it wasn't, Some 20 members of the University of Pennsylvania Law School faculty, appeared to be expressing widespread sentiment when they declared: "It is one thing to say that Judge Carswell should not be rejected solely on the basis of views expressed as a young man. It is quite another matter, however, to elevate to the Supreme Court a judge whose principal distinctions appear to be his Southern heritage and his lack of investment in the securities market."

No opposition was uttered more eloquently and with greater justification than that of Senator Brooke. Exercising his obligation as Senator to give his advice to the President on the matter, Senator Brooke said on the floor of the Senate that this is a most inappropriate time in history to appoint Judge Carswell to the Supreme Court. The Massachusetts solon had searched the record failrly and patiently, failing to find evidence that the nominee had given of a true dedication to the principle of equal rights under the law. He concluded that Judge Carswell, as a federal district judge, "appears to have consistently moved at the slowest possible pace, repeatedly stretching out judicial action and effectively delaying relief."

Ed Brooke, Judge Carswell's contemporary in age used characteristic restraint in protesting the appointment as one who had good reason to feel down-graded by the jurist's inexcusable racial attitude. But when he spoke out, the Senator--in withholding his consent to the appointment---spoke more as a champion of national idealism and universal concern than he did as a black man sitting in judgement. And this to his great credit,
