To the Editor:

In The B'nai B'rith Messenger of Feb. 6, 1970, Rabbi Eichhorn, author of a volume that deals with the problem of conversion and intermarriage, stated that according to the Halacha, the children of the Israeli Lt. Com. Benjamin Shalit are Jewish although their mother is not Jewish; and neither she or her children were converted to Judaism. He bases his ruling upon the Shulchan Aruch, Yoreh Deah, chapter 268, Section 11. He cites the above section as follows: "One who has been living for a long time in the Jewish community and who declares: 'I was born as a non-Jew and I became a Jew simply by living a Jewish life and I consider both my children and myself to be Jews' is not considered to be a Jew, but his children are conaidered to be Jews."

I wish to state that the entire citation is misconstrued and misinterpreted. In order to understand the text of the Shulchan Aruch, one has to study first the Talmud, the source from which the Law is taken The Talmudic source from this section of the Shulchan Aruch is taken from the Talmud, Yebamoth 47a Our Rabbis taught: And judge righteously between a man and his brother, and the proselyte that is with him; from this text did R Judah deduce that a man who becomes a proselyte (who had been circumcised and performed the prescribed ablution) in the, presence of a Beth Din is deemed to be a proper proselyte; but he who does so privately is no proselyte (as a judicial matter requires a Beth Din, so does the initiation of a proselyte).

has children, and says: I became a proselyte privately. We trust him to disqualify himself, but we do not trust him to disqualify his children!"

And so also brings the Shuchan Aruch in Yoreh Deah, chapter 268, section 11, "If one who was known as a Jew says, 'I became a proselyte privately' (not before a Beth Din). If he has children, he is not

It once happened that a man (who was known as a Jew and was married to a Jewess — Tosafot) came before Rabbi Judah and told him "I have become a proselyte privately" (Not before a Beth Din, and therefore he is not a Jew). "Have you witnessess." Rabbi Judah asked "No," the man replied. "You are trusted," the Master said to him "as far as your own dis-

qualification is concerned, but you cannot be relied upon to disqualify your children." (And we maintain, therefore, that your children were born from a Jewish mother and also from a Jewish father). This ruling of Rabbi Judah, is brought by the Rambam as a law in the Yad Hachazaka. Hilchot Isurei Biah chapter 13, section 8, the rule reads as follows: "If one is married to a Jewess or to a proselyte, and trusted to disqualify his children, but he is trusted to disqualify himself"

We say we do not trust him to disqualify his children and since his mother was Jewish, we maintain that the children are Jewish without any blemish. However, in the case of Lt. Com. Benjamin Shalit's children, whose mother was not born Jewish, and neither she nor her children converted to Judaism, though the father is a Jew, the children are not Jewish as it is ruled in the Mishneh Kidushin 66 B and in Rambam Hilchot Isurei Biah Chapter 15, Section 4, and in the Shulchan Aruch, Eben Haezer Chapter 8, Section 5.
