## CAR FIRMS

NEW YORK (WNS) -The Conference of Presidents of Major American Jewish Organizations charged that Japan Air Lines and the Toyota Motor Co. and the Nissan Motor Co., manufacturer of the Datsunauto, were submitted to the Arab boycott of Israel.

The two auto firms are leading distributors of cars throughout the world. But the Jewish group noted that neither had franchises and dealerships in Israel. A Toyota executive was quoted by the Conference as declaring it had considered doing business with Israel but that it trades with Egypt and encountered boycott threats." The Nissan firm told an Israeli motor sales company in a letter that "we are now exporting 20,000 units a year to the Arabic countries. . . The boycott restrictions. ... will surely create the total ban of our exports to the Arabic countries."

The Jan stalled a mutual air agreement with Israel that would give JAL and El Al landing rights in the other's nation. But JAL had held talks on the matter with Israel last month and an Israeli delegation is due to meet Japanese air authorities in Tokyo later this month.

The Conference said that the Japanese companies had given in to the boycott because the Tokyo government, while friendly to Israel, failed to adopt a policy protecting Japanese industry from Arab pressure.

BOYCOTT Many Japanese forms have ignored the boycott and were trading with Israel and the Arabs while other nations have opposed the boycott and companies in these countries were successfully ignoring the boycott.



Supreme Soviet, Russia's parliament, has completely ignored requests from 85 Soviet Jews for permission to emigrate to Israel. The Jews had issued appeals to coincide with the current session of the Soviet legislative body.

Three different groups of Jews made the appeals to the Supreme Soviet. One petition was signed by 45 Moscow Jews, another by 10 Moscow Jews and the third by 30 Latvian Jews. The letter from the 10 Muscovites challenged the Russian government to arrest them for sedition if they are now allowed to leave for Israel.

(In Israel, the Public Council for Soviet Jewry held its foulding assembly in Jerusalem. During the meeting a letter from a Russian Jew answering an anti-Israel attack by Soviet Jewish Gen. David Dragunsky was read. The writer, V. Polsky, declared that "the hatred against the Jews of Israel which you foment is going to boomerang against the Jews of the Soviet Union.
