A three-credit course in television production, offered during the second summer session at the University of Nevada, Las Vegas, will meet from 11:30 a.m. until 1:30 p.m., Monday through Friday, July 23 - August 28 in the University Studio, located in Frazier Hall on Campus.

More than 125 classes, seminars and special workshops will be offered during the second summer session at the University of Nevada, Las Vegas. Courses from every department in each of the Colleges at UNLV will be available during the five and one-half week term, July 22 through August 28.

Two Black Studies courses, each carrying four credit-hours will be offered at UNLV during the second summer session which begins July 23. Registration for the courses will be open July 22 in the Student Union from 8 to 11 a.m. and from 1 to 4 p.m.
