EGYPTIANS SWIM IN SUEZ CANAL, FIGHTING SHIFTS TO EAST BORDER

TEL AVIV (WNS)--The silence of stilled guns and grounded jet fighters is shattered only by the splashing sounds of Egyptian soldiers swimming in the Suez Canal as a 90-day cease fire between Israel and Egypt went into effect along the waterway battle line last week.

Fighting in the Mideast has shifted to Israel's frontiers with Lebanon, Syria and Jordan where Arab terrorist organizations have stepped up their raid and shelling of Israeli border settlements and army patrols in what guerrilla leaders have declared is an all-out effort to destroy the cease-fire.

The cease-fire agreement provides for Israeli self-defense measures against terrorists, a tacit recognition that Jordan and Lebanon don't have the means and Syria doesn't have the desire to stop commando groups. Jordan has indicated its regular forces would respect the cease-fire and wouldn't support terrorist raids against Israel with covering artillery and mortar fire. But Jordanian forces will make no attempt to prevent commando strikes against Israel.

Syria is believed to be following a similar military stance as is Lebanon.

During the first days of the cease-fire terrorists launched shelling along the length

of Israel's eastern border running from the Golan Heights to south of the Dead Sea.

The cease fire came too late to prevent the downing of an Israeli Phantom jet by Egyptian ground fire.

The two men aboard the plane were captured when they bailed out onto Egyptian territory. The two men bring to 14 the numbers of prisoners now held by Egypt.

The Phantom was the 14th Israeli jet lost to the Arabs since the end of the Six-Day War. The cease-fire terms call for a halt in all military activities in a 32-mile zone along both sides of the canal.

United States and Russian spy satellites and electronic ships in the Mediterranean Ocean will aid in observing the cease fire. About 100 United Nations observers on both sides of the canal will also help police the agreement.

The French newspaper Le Figaro said that before the Soviet pilots ejected from their planes one was heard to shout over his radio in Russian: "The dirty Jews."

Le Figaro also claimed that 100 Soviet military personnel, including a major, general and colonel were killed,

SILBERMAN FOR HOSP. TRUSTEE

Las Vegas resident and property owner, Arthur Silberman, was the first to file for the non-partisan position of Clark County Hospital Board Trustee from inside Las Vegas. A revenue clerk for Reynolds Electrical & Engineering Company (RE ECo) at the Nevada Test Site, his position involves the handling of an accounting for thousands of AEC funds each week.

A veteran of the Marine Corps in World War II, Arthur - now age 42 - is a past commander of an American Legion post, and was cited by the Department of Illinois for his outstanding achievements. He and his wife Caroline are members of Beth Shalom Synagogue and also attend the Couple's Club regularly. Their two children are in the Las Vegas schools, and Arthur's son attends the University of Illinois.

Silberman is very civic minded having served as a member of the precinct election board during the past two Las Vegas (City) elections. He has served in this capacity ever

since his eligibility to become a Nevada voter in 1968. Prior to coming to Nevada he was an Election Judge in Illinois since 1952, is a past president of the Gems chapter, Illinois Psychiatric Aid Society; Past Secretary, Illinois Divisions 4 and 17 Kiwanis Club; Past Secretary, Kiwanis Council for Crippled Children, and in 1967 he ran for City Park District Commissioner as a non-partisan independent candidate without any backing except his immediate family and came within a few hundred votes of unseating the partisan incumbent.

Silberman is qualified for the office he weeks, being not stranger to political positions. While residing in Illinois, he was a member of the Advisory Board of the Department of Parks and Recreation, chairman of a school PTA Recreation

and Youth Services Committee for two years, a nominee for the Mayor's Community Relations Commission of Evanston in 1964, and in Nevada served as a member of the NTS Federal Credit Union Credit Committee.
