PEACE TALKS BEGIN

United Nations (WNS)-Talks of a "just and lasting peace" in the Middle East got under way when United Nations Mediator Gunnar V. Jarring met separately with Ambassadors from Israel, Egypt and Jordan

The talks began just 18 days after the United States sponsored cease fire went into effect. After meeting twice with Dr. Jarring, Israeli Ambassador to the UN Yosef Tekoah, left for Israel for consultations with his government.
