\$1 million in military aid because American officials are now convinced that the military balance has shifted away from Israel. The exact extent of this shift was being discussed, but civilian and military planner analysis indicated that Israel would lose substantial aircraft if fighting resumed along the canal and Israel might have to change its defense efforts and move away from the waterway deep into the Sinai Peninsula. Many military officials were reported coming to the conclusion that Israel couldn't absorb the "terrible losses of pilots and planes" needed to re-establish air superiority over the canal. The military aid to be offered to Israel was designed to lessen Israel's growing military weakness.

AJC ASKS SUSPENSION OF AIR SERVICE TO HIJACK COUNTRIES

NEW YORK -- The president of the American Jewish Committee urged President Nixon to take action, in the United Nations and other international organizations, "to effect the total suspension of all air service" to and from countries that aid and abet hijackers. He also called for an immediate appeal to countries throughout the world "to outlaw and punish with the severest possible penalties attacks against civil aircraft."

In a telegram to the President, Philip E. Hoffman also declared that his organization "was dismayed and distressed" by reports that passengers on the planes that were hijacked to Jordan last Sunday were being separated on the basis of religion, and that "there is the grave possibility

that Jews may be subject to special harassment and abuse." "The unconscionable actions of last week-end are not the first and will not be the last unless worldwide outrage results in effective action," Mr. Hoffman stated, and continued: "The governments of all law-abiding countries have a profound obligation to bring unrelenting pressure to bear against those who continue to aid and abet this international lawlessness. It is also incumbent upon the Uni-

ted Nations to put an end to these flagrant acts of defiance of its Charter and its human rights conventions." Mr. Hoffman reminded the President of a statement he made to the United Nations General Assembly last year, in which Mr. Nixon stated that such barbaric actions are "morally, politically, and legally indefensible", that they endanger "every nation, the safety of every air passenger, and the integrity of that structure of order on which a world community depends."
