EL AL STARSTS CANADA RUN

El Al Israel Airlines, which for the last twenty one years has operated regularly scheduled service between Israel and the United States, will begin scheduled service between Israel and Canada Spring, 1971. This will be the national flag carrier's second North - American gateway.

A new air pact has been initiated by the two Governments which will provide for four weekly flights each to

be performed by El Al and Canada Pacific Air between Tel Aviv and Montreal, thus giving the two countries a daily airlink.

"We are confident that tourism between our two countries will receive a considerable boost from this development," said M. Cohen, vice president of El Al in North America. The opening of the Canadian route will coincide with the carrier's introduction of 747 service.
