Frank Young, Republican, has served two terms in the Nevada State Assembly and now seeks a third term in that Assembly.

Mr. Young is a graduate in nuclear engineering of Yale University and is presently a Senior Scientific Executive and nuclear engineer with EG&G Inc. having been with EG&G in Nevada since 1958.

In the 1969 Legislature he introduced an act to make Nevada a party to the Western Interstate Nuclear Compact; this act was passed by the Legislature and he is now Nevada's representative to and the Chairman of the Western Interstate Nuclear Compact consisting of eleven western states. Recently at the National Science Foundation in Washington, D.C., Assemblyman Young was elected a member of the six man Executive Committee of the Governors' Council on Science and Technology.

Mr. Young was the sixteenth man to be licensed by the United States Atomic Energy Commission to operate a nuclear reactor, and he has taken a deep interest in ecology throughout his

career, recognizing clean air as an imperative.

Recently Assemblyman Frank Young and his wife Jean celebrated their 21st wedding anniversary with their two high school sons, Bob and Rick.

Assemblyman Frank Young is Associate Lay Leader of University United Methodist Church in Las Vegas. He is a board member of the Salvation Army and the Boy Scouts.

A Navy veteran, he was on the Staff of the Admiral Commanding at the 1946 Bikini Tests.

In the Nevada Assembly he is vice-chairman of Taxation and Legislative Functions Committee and

member of Ways and Means. As a nuclear engineer he has followed closely the pioneer use of radioactive substances for medical purposes by the famed City of Hope National Medical Center at Duarte, California.
