NEW YORK (WNS)-As protests against the forthcoming showtrial of Soviet Jews continue to mount, leaders of the American Jewish Conference on Soviet Jewry met with officials of the of Pres-Conference idents of Major American Jewish Organizations and made plans for the formation of a committee of lawyers which would attempt to represent the Soviet Jews who will be tried on charges of allegedly attempting to hijack a Soviet airliner.

At the same time, the heads of 27 major American Jewish organizations wrote to Soviet President Nikolai V. Podgorny objecting to the trial as "based on false accusations designed to repress Jewish consciousness." - A similar telegram was sent from Brussels by the Coordinating Committee of Belgian Jewish organizations.
