

Plea to Save Russ Jews

"We, Soviet citizens of Jewish nationality, find ourselves compelled to turn to you with an important request. We turn to you with great hope. Our husbands and close relatives were arrested on June 15 and August 5, 1970. The arrests were made on the basis of charges that can only be the result of a monstrous error. The hijacking on an airplane and anti-Soviet activity have been charged. All those arrested were at home or at work at the time of the arrests. All of our apartments were searched. Hebrew-language textbooks, dictionaries, textbooks on Jewish history, tapes of Hebrew poems and songs, letters and postcards from Israel, return receipts of letters sent to Israel, as well as Jewish books, and all printed materials containing the words 'Israel,' 'Jew' or 'Jewish,' were taken away.

"Our husbands and close relatives, like ourselves, fervently desired, and still desire, to live in our HISTORICAL HOMELAND and to educate ourselves and our children in the spirit of our people. Consequently, the whole of the 'anti-Soviet activity' consists of the fact that our husbands and relatives sought to realize their cherished dream by entirely lawful means.

"Many of our families submitted applications for permission to go to the State of Israel; others were planning to submit applications in the very near future. All who submitted their papers to OVIR (Note: Department of Internal Affairs Ministry) were refused permission to carry out their legitimate desire to live among their own people, after which letters and complaints were sent to the Soviet government and to Soviet representatives at the United Nations. Nothing has yet been done about this crude violation of Soviet laws by OVIR employees. On the other hand, the situation of our relatives and ourselves is disastrous. The plans and dreams of our lives have been destroyed. Many of us have been left with small children and, in fact, with no means of subsistence. All who have been arrested are in danger of very severe penalties if what has happened and what is happening now is not cleared up in time.

ONLY RESCUE MOBILE UNIT

A RESCUE mobile unit from the University of Nevada, Las Vegas this week will be rolling to the aid of residents of the city's West Side and North Las Vegas.

Inside the large silver coach will be students and staff members of UNLV's Department of Social Services dealing with the problems of the community by counseling with its people in their own neighborhoods.

Purchased through a federal education grant, the five-ton vehicle will play a principal role in the development of the newly-established RESCUE project at the University. The initials stand for Recruitment, Experience and Service for Community and University Education.

Project director Esther Langston said the bus will be parked each week in two of the areas largest poverty pockets; H Street and Owens from noon until 3:30 p.m. every Tuesday; and at 310 E. Lake Mead Boulevard from noon until 3:30 p.m. each Thursday.

Also, the unit will be at UNLV from 9 a.m. until noon each Wednesday.

ARAB TERRORISTS NOW TALK HONEY

The Palestine Liberation Movement has changed its propaganda tactics but not its goal of destroying Israel, a spokesman for the American Jewish Congress said.

Richard Cohen, Associate executive director, told the annual meeting of the organization's St. Louis Council:

"Arab terrorists no longer talk about driving Israel into the sea, recognizing that this kind of inflammatory language turns off fair-minded Americans.

"Instead they talk of creating a 'democratic, secular state' in Palestine where -- it is claimed -- Jew, Moslem and Christian will live together in peace and brotherhood.

"The falsity of this claim can be seen not only in the experience of hundreds of thousands of Jews who fled persecution in Arab countries but in analyzing the Palestinian National Covenant itself. This Covenant, adopted by the Palestine National Council in Cairo in July 1968, might best be compared with the battle plan Hitler gave the world in his MeinKampf.

"The concept of a 'democratic, secular state' is expressly con-

tradicted in the Covenant's statement that the only Jews who will be permitted to remain in 'liberated' Palestine will be those who inhabited the area prior to 'the beginning of the Zionish invasion.'

"The date of this 'invasion' was set in 1917 by the First Palestine Congress. More than 2 million Israelis who did not live in Palestine in 1917 would therefore be expelled from the new Palestinian nation -- hardly a promising start for a 'democratic, secular state.'"

Other articles in the Palestine National Covenant, which Mr. Cohen said was not widely known by the American public, declare that:

"Armed struggle is the only way to liberate Palestine."

"The liberation of Palestine from an Arab viewpoint is a national duty...to purge the Zionist presence from Palestine."
