Frumkin concluded. The Candlelight Walk is scheduled to take place on the first night of Chanukah because Chanukah commemorates the first victory of an oppressed people against overwhelming odds. The small village of Modin in Israel was the site of the beginning of an armed revolt by the Maccabees in 150 AD, a revolt which succeeded in defeating the Syrian armies occupying Israel at that time, and establishing a free Jewish state.

"The torch of freedom which was lit at Modin 2000 years ago has been lighting the way for all who begin to despair when oppression and tyranny seem to be invincible," said Zev Yaroslavsky, chairman of the California Students for Soviet Jews, "and we know that this light will light the way to freedom for the oppressed Jews

of Russia. Once again political show trials are starting in the USSR, and we are witnessing the beginning of mass arrests. A holocaust must be prevented before it begins, and only a massive show of concern will make the Russians let the Jews go."

The symbolic Torch of Freedom will be lit at the original site of the revolt in Modin, Israel and will be carried by relays - plane, auto and runners - to Los Angeles. The Massada Youth Group of the ZOA will provide the young people who will bring the light to the Candlelight Walk, and it was this group that was instrumental in arranging for the lighting and the delivery of the symbolic light.

The Candlelight Walk will begin at the Music Center at 6:30 PM on December 22 when all of the participants, carrying candles, will walk to the steps of the City Hall where they will be met by a group of dignitaries for a brief ceremony which will involve lighting the symbolic Menorah of Freedom to honor the imprisoned Jewish Freedom Fighters of Russia. A brief dramatic reading and an address by Tom Bradley will conclude the program.

**34TH SOVIET JEW ARRESTED**

NEW YORK (WNS)- Another Soviet Jew who had applied for permission to emigrate to Israel, Semeon Abramovich Levit of Kishinev, has been arrested, the American Conference on Soviet Jewry and the Student Struggle for Soviet Jewry announced this week. (In Washington, D.C., several thousand persons attended a mass rally.) This brings to 34 the number of Soviet Jews arrested in recent months. Thirty-three Jews are now awaiting a "show trial" scheduled to begin on Dec. 15, on charges of allegedly planning to hijack a Soviet airliner.

Meanwhile, the State Department announced that it had "strong concern" for the situation of Soviet Jews seeking to emigrate to Israel, but feared that "open intercession" on its part would be counterproductive.

At the same time, a bipartisan group of 67 members of the House of Representatives sent a letter to Secretary of State William P. Rogers, urging him to "confirm immediately" the U.S. citizenship of Leonid Rigerman, a 30-year-old Soviet Jew who was arrested on the

steps where he had filed application for American citizenship, on the grounds that his mother is American-born and his father is a naturalized American citizen.

In New York, the SSSJ announced that 100 high school and college members were conducting a house-to-house campaign in the Flatbush section of Brooklyn to urge them to send telegrams to Secretary Rogers and Soviet Ambassador Abatoly F. Dobrynin demanding the release of Leonid Rigerman.

**DAYAN STAND**
